# THE CHRISTCHURCH CITY COUNCIL DRAFT ANNUAL PLAN 2006

The Hagley/Ferrymead Community Board (the Board) makes the following submissions on the Christchurch City Council Draft Annual Plan 2006. The Board would like to be heard in support of its submission.

### **FUNDING IMPACT STATEMENT - PAGE 22**

1. The Board recognises that all Territorial Local Authorities, TLA's, help fund the museum. As the Christchurch City Council is the major contributor, but one of a number, this should be separated as a line item on its own.

#### PERFORMANCE MEASURES- ALL

2. The Board submits that consideration needs to be given to the amount of performance measures contained in this document. The Board believes there are too many. Measures need to be concise and measurable.

## **CITY DEVELOPMENT – PAGE 32**

3. The Board supports and commends the Council for the current work it is doing on the Turners & Growers and Lichfield Lanes sites and the 'can do' attitude towards inner city living. The Board would like to recommend a change in the performance measure for promoting the central city as a place to be, page 36.A change to the target of 10,000 people living in city centre by 2007 not by 2010. Current statistics for people living in the city centre support this as an achievable target.

## **CITY DEVELOPMENT – HERITAGE PROTECTION - PAGE 35**

4. Heritage buildings comprise 0.45% of the buildings in Christchurch. The Board supports the measures that are being taken and the continuation of heritage protection.

#### **COMMUNITY SERVICES - PAGE 37**

- 5. The Board strongly recommends that the current Council Housing Policy be reviewed to rethink its procedure of housing elderly tenants with the mentally disabled or challenged.
- 6. The Board recommends that the Council fund O.S.C.A.R and other holiday programmes, their administration and supervision on a metropolitan basis.
- 7. The Board endorses Council run events and festivals and proactively encourages staff to formulise bids for national and international cultural and sporting events to be held in the city.

8. The Board supports the continuation of funding for Art in Public Places for 2005/06.

#### PARKS AND OPEN SPACES- PAGE 55

9. To alleviate the shortage of sports grounds the Board recommends that the Community Facilities Unit work constructively with the Greenspace Unit with a view to establishing junior sports grounds, for winter and summer sport, being played on local reserves, to cater for local families.

#### STREETS AND TRANSPORT - PAGE 71

10. In an attempt to enhance the CBD with short-term parking, the Board encourages the Council to make some of the smaller CBD streets one way and install rear end parking.

### LONG TERM COUNCIL COMMUNITY PLAN 2006-2016

- 1. The Board welcomes the opportunity and encourages the Council to build a new aquatic leisure facility in the Hagley/Ferrymead ward. Provision for this future facility in the ward needs to be made in the 2006-2016 LTCCP. A specific site, on Council land, within the ward and a needs analysis has been completed by the Board.
- 2. The Board submits that provision be made in the 2006/16 Long Term Council Community Plan for continued funding for Art in Public Places of \$250,000 capital and \$7,500 operating expenditure.
