We are the owner of the property known as The Crossing.

We support the extension of the Tram into City Mall. We note that it is proposed to remove the airbridge that links into our building. We have been in discussions with Council on this and can support this “in principle”.

We note also in the pamphlet that a tram-stop is proposed in City Mall between Colombo and High Streets. Again, we are supportive “in principle” on this, but would request to be consulted on its proposed location. We would also wish to be informed of details regarding any proposed building structure and be given the opportunity to make comment regarding this building structure.

Finally we support the extension of the tram to the Java Café area on the route proposed in the pamphlet. This will introduce tourists to South of Lichfield Street which will be very positive.
