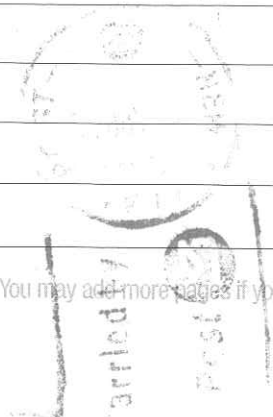
It is important that if in your submission you clearly state your opinion on the proposed route and describe/outline any ideas/issues you may have.
