6. CASUAL AND CONCESSION CARDS POOLS AND FITNESS CASUAL ADMISSIONS

The purpose of this report is to seek the Council's approval to alter the description of the beneficiaries, senior citizens, people with disabilities, unemployed, students and community service card holder concessions for our casual pool entry and casual weights and fitness entry.

During the Annual Plan process we excluded students from the concession for pool and weights/fitness membership on the basis that a significant number of the students joining the Council facilities are not full time students and have part-time or fulltime employment. Those students who do not have sufficient income are eligible to apply for a community service card that would enable them to obtain the appropriate discount.

ISSUE FOR CONSIDERATION

In implementing the above change at the facilities we have now created an anomaly in that any student providing a student identification (ID) card can receive a discount for casual use but not for a membership.

The issue that we are trying to correct is that the concession that the Council is providing is to support people, who are on a limited income or no income, to access the Council facilities. The issuing of a student ID card is not based on any criteria relating to income or disability.

To ensure that this concession is not abused the following description/definition is now proposed:

NZ Super Card – to cover senior citizens receiving Government superannuation.

Community Services Card – will cover beneficiaries, unemployed or students who have left school who are eligible for this card due to income restraints.

KiwiAble Leisure Card – CCC card available for people with disabilities.

Secondary School Student over 15 – New category – Pools only

Secondary school students who are able to provide current school identification will be eligible for child rates, ie \$2.00 for pool entry. This is no change from the interpretation of our fees schedule at present but clearly defines accessibility.

CONCLUSION

We do not anticipate any significant additional income from this proposal. However, it will clarify for our facilities customer services staff the eligibility for concessions. Indications are that staff at facilities would have difficulty explaining the anomaly with the non-availability of a student ID membership when casual concessions apply. This change, however, will impact on overseas students using our facilities who do not qualify for a Community Services Card but have been using their student ID cards for entry. Based on the purpose of the concession we do not consider that they should be receiving a discounted entry to our facilities.
