1. APOLOGIES

An apology was received and accepted from Cheryl Colley.

2. ELECTION OF DEPUTY COMMITTEE CHAIRMAN

George Hampton was elected as Deputy Chairman of the Committee for the present Board term.

3. PROJECT FUNDING ALLOCATIONS 2002/03

The Committee considered a detailed report setting out possible projects for which the Board's \$250,000 could be allocated against. A number of current commitments along with new proposals submitted by members, staff and the community were elaborated on in the supporting papers.

\$60,000 still remained available as the Board's discretionary allocation for next year along with a further \$40,000 for community workers and \$40,000 for SCAP.

The following recommendation results from the Committee's detailed consideration of all the information submitted.

(Note: Mike Wall declared an interest regarding the allocation of the funding to the CAB and withdrew from the meeting during the consideration of this item.)

4. BOARD OBJECTIVES AND PERFORMANCE INDICATORS FOR 2002/03

Further to a background report from the Community Advocate, the Committee **decided** that the development of the Board's objectives and performance indicators for 2002/03 be referred to the Chairman and the Chairs of the Board's Standing Committees for further consideration and report to the 26 February meeting of the Board. A copy of this outcome is **attached**.

5. 2001/02 DISCRETIONARY FUNDING – ALLOCATION OF REMAINING FUNDS

The Committee was advised that \$9,750 remained to be allocated from the Board's current discretionary budget. An earlier allocation of \$2,000 towards traffic calming measures in Weston Road was also available for re-allocation given the intention to fund the kerb build-outs at the Western Road/Bretts Road intersection from next year's project funding.

Similarly, the Committee noted the \$12,000 assigned to Weston Road (ex Fendalton Library car park) should now be returned and used for the Fendalton project as originally intended.
