The purpose of this report is to provide an update on the 2001/02 Project and Discretionary funding allocations and expenditure.

The funding available to the Board for the 2001/02 financial year is \$390,000, made up of:

Project	\$250,000
Discretionary	50,000
Community Development Workers	50,000
Strengthening Communities Action Plan (SCAP)	40,000
	\$390,000

An additional \$8,900 is available from funding returned or carried-forward from 2000/01.

Note that the Funding Assessment Committee administers funding for the Hillary Commission Community Sport Fund and the Community Development Scheme. In the 2001/02 funding round there is \$41,368 available under the Hillary Commission and \$50,766 available under the Community Development Scheme (including \$10,000 allocated from the Board's funds). The report of the Funding Assessment Committee's allocation meeting on 8 May 2002 will be circulated separately for the Board meeting on 27 May 2002.

## DISCRETIONARY FUNDING

The Board retained \$34,950 in Discretionary funding for allocation during the year. Additional funding is available from:

- \$1,900 of unallocated 2000/01 funds carried forward to 2001/02.
- \$7,000 reallocated from 2000/01 allocations (Prime Time House \$3,000, B Pacific Cultural and Arts Group \$2,000, Waipuna/Hebron Trust \$2,000).
- \$4,546 reallocated from 2001/02 Project allocations (Mature Employment Service \$3,000, Waipuna/Hebron Trust \$1,000, Neighbourhood Week \$546).

The total Discretionary funding available for allocation is therefore \$48,396.

To date a total of \$38,150 has been allocated leaving a balance of \$10,246 available for use up to 30 June 2002.
