

2. 2002/03 FUNDING ALLOCATIONS - UPDATE

The purpose of this report is to provide an update on the 2002/03 Project and Discretionary funding allocations and expenditure.

The funding available to the Board for the 2002/03 financial year is \$390,000, made up of:

Project and Discretionary	\$300,000
Community Development Workers	50,000
Strengthening Communities Action Plan (SCAP)	40,000
	<u>\$390,000</u>

The payment of \$22,000 of 2002/03 Project items was brought forward for payment from the residual 2001/02 Discretionary funds and other surplus funding. Payment of \$10,000 to the Parklands Baptist Community Church was deferred from 2001/02.

DISCRETIONARY FUNDING

At the allocation meeting on 20 February 2002 the Board retained \$37,500 in Discretionary funding for allocation during the year. The net increase of \$12,000 obtained by adjustments between the 2001/02 and 2002/03 items increased the funds the total available Discretionary funds for 2002/03 to \$49,500. Additional funding of \$10,000 was reallocated by the Board from the 2002/03 Project allocation to Out of School Programme Support.

The total Discretionary funding for 2002/03 is therefore \$59,500.

To 17 February 2003 a total of \$42,507 has been allocated leaving a balance of \$16,993 available for use up to 30 June 2003.

PROJECT FUNDING

The Board allocated funding of \$352,500 on 20 February 2002 comprising \$262,500 of Project funds, \$50,000 for Community Development workers and \$40,000 of SCAP funds. (A total of \$10,000 of this has subsequently been reallocated to Discretionary Funds.)
