### 16.1 ELECTION OF CHAIRPERSON

The Committee **resolved** to elect Linda Rutland as its Chairperson.

### 16.2 GRAND LODGE OF NEW ZEALAND R.O.A.B. – LEGAL ARTS PROJECT

The Committee considered a request from the Grand Lodge of New Zealand R.O.A.B for funding for a recently completed mural at its premises on Ferry Road. The mural was completed in conjunction with the Council's Legal Arts Programme. The request for funding was referred to the Committee by the Board on 20 November with Power to Act.

The Committee allocated \$500 discretionary funding to the Grand Lodge of New Zealand R.O.A.B. for the mural.

# 16.3 COMMUNITY EVENTS & SPECIAL DAYS FUND

The Committee considered a report from the Community Recreation Advisor identifying events and celebrations in the Board's area that could be funded from the Community Events and Special Days Fund. The Committee **resolved** to make the following allocations from the Community Events and Special Days Fund:

The Committee also **resolved** to transfer \$80.00 from the Community Events and Special Days Fund to the Community Response Fund to cover a grant to the Ferrymead Brookhaven Residents' Association for a Community Event/Christmas Picnic.

The Committee requested a map showing events in order to identify potential areas for funding.

David Cox requested that it be noted that the Board may accept sponsorship for Community Events and Special Days that were initiated at the Board's request or as Council service delivery.
