- (g) A bus company representative.'

An invitation to nominate a representative was sent to the organisations listed above and nominations have been received as follows:

- (b) The Mayoral Forum at its meeting on 19 November 2002 resolved to nominate Mr Steve Collins as its representative.
- (c) The Canterbury Employers' Chamber of Commerce has nominated its Chief Executive Officer, Mr Peter Townsend.
- (d) Environment Canterbury have confirmed Councillor Diana Shand as its representative.
- (e) The NZAA has nominated Mr Tom McBrearty, Regional Chairman, NZAA, as its representative.
- (f) SPOKES have nominated Mr Glen Kooray as its representative.
- (g) Mr Greg Campbell, CEO, RedBus Company, has nominated Mr His Admiraal as a representative of his company.

An additional two representatives of central city businesses are, however, still required to be appointed.
