The purpose of this report is to provide information on a project being undertaken by the Road Safety Co-ordinating Committee.

### REVIEW OF THE CHRISTCHURCH ROAD SAFETY STRATEGY

The Road Safety Co-ordinating Committee has approved an update review of the Christchurch Road Safety Strategy. The basis for the review is as follows:

#### Desired Outcomes

- Updated and relevant Christchurch Road Safety Strategy owned and acted on by the Road Safety Co-ordinating Committee, committed to by member organisations represented on the Christchurch Road Safety Co-ordinating Committee and promoted to the Christchurch community.
- A celebration of what has been achieved with the current strategy, identification of what we have yet to achieve and investigation of new challenges and issues that may have since arisen.

#### Objectives for the Review of the Christchurch Road Safety Strategy

- Update the Christchurch Road Safety Strategy in a way that involves members of the Road Safety Co-ordinating Committee, and the Christchurch City Council.
- Review the strategy in a way that recognises, assesses and celebrates what has been achieved.
- Include measures for monitoring progress of strategies and progress towards achievement of the strategy outcomes.
- Promote the strategy to the key staff of the organisations responsible for implementing the strategy.
- Promote the updated Road Safety Strategy to the wider community.
