

10. INSTALLATION OF TRAFFIC SIGNALS AT THE INTERSECTION OF ACHERON DRIVE AND BLENHEIM ROAD

The purpose of this report is to seek approval for the installation of traffic signals at the intersection of Acheron Drive and Blenheim Road (west of Wharenui Road), subject to full community consultation. Approval for the installation of signals is required before a resource consent and building consent can be issued.

This report is also being presented to the Riccarton/Wigram Community Board on 1 October 2003 for their information.

BACKGROUND

The Council has received an application for a resource consent and a building consent for a development in Acheron Drive at the location shown on the attached plan. To mitigate the effects of traffic generation from the site the developer has agreed to pay the full cost of installing traffic signals at the intersection of Acheron Drive and Blenheim Road (west of Wharenui Road).

City Solutions were engaged by the developer to prepare a scheme plan, in consultation with the City Streets Unit.

THE PROPOSAL

The proposal to install traffic signals at this intersection is shown on the attached plan and has the full support of the City Streets Manager.

This intersection will be controlled by and form part of the existing signalised intersection at the Blenheim Road/Wharenui Road intersection. The operation will be similar to that of the Clyde Road/Riccarton Road/Wharenui Road intersection where the approaches to both intersections go green at the same time.

As shown, the proposal incorporates a free left turn from Acheron Drive and pedestrian facilities across Blenheim Road and Acheron Drive.

These signals will improve the access from the whole of Acheron Drive to the north and east, as currently a solid median exists on Blenheim Road across the intersection. The signals will also reduce the number of 'U-turners' on the east approach of the Blenheim Road/Wharenui Road intersection who will now be able to exit from the western end of Acheron Drive to head east.

The proposal also incorporates a fully developed access to the site off Blenheim Road with the provision of an inset bus-bay. The existing bus stop is too close to the Acheron Road/Blenheim Road intersection and is to be shifted west. The existing footpath will be used to develop the left turn lane and bus-bay, but land for an equivalent 2.0 metre footpath and 3.5 metre footpath with bus shelter will be vested in road by the developer.

As a ban on parking currently exists on Blenheim Road, this is not seen as an issue.

CONSULTATION

The City Streets Unit have engaged City Solutions to project manage the project, including the consultation, with all costs being paid for by the developer.

Because of the relatively tight timeframe for the development project (completion by April 2004), it is proposed to proceed to public consultation in early October 2003 and report back to the Committee in November 2003. If approved, a contract to install the signals will be let in February 2004.

CONCLUSION

As part of a resource consent for a large retail development near the southwest corner of the Acheron Road/Blenheim Road intersection (west of Wharenui Road), the developer has agreed to pay the full cost of installing traffic signals, including associated kerb work.

The new signals will form part of the existing Blenheim Road/Wharenui Road intersection and operate in a similar manner to the Clyde Road/Riccarton Road/Wharenui Road intersection.

The new signals will provide a safe, controlled access onto Blenheim Road for all traffic from Acheron Drive, but especially for traffic heading north and east. A solid median on Blenheim Road currently exists across both Acheron Drive/Blenheim Road intersections. The signals will also assist traffic currently exiting the eastern end of Acheron Drive and 'U-turning' at the Blenheim Road/Wharenui Road intersection.

- Recommendation:**
1. Approval be given to consult with the public on a proposal to install traffic signals at the western intersection of Acheron Drive and Blenheim Road.
 2. That traffic signals be installed at the western intersection of Acheron Drive and Blenheim Road, subject to successful public consultation.
