

11. COMMUNITY ADVOCATE'S UPDATE

11.1 SUMNER BUS SHELTER

The Board considered a report providing an update on progress towards adding a roof over the seat at the bus stop at the corner of Marriner Street and Wakefield Avenue.

The Board **received** the information.

11.2 GARDEN AWARDS

The Board considered a report outlining the process for the distribution of garden awards to recipients.

The Board **decided** that, as part of the next garden awards competition, elected members would be given the opportunity to personally deliver garden certificates within their Ward areas.

11.3 WOOLSTON MAINSTREET

The Board considered a report outlining the proposed programme of works for Ferry Road in the Woolston Mainstreet area and the discussions which had taken place on the timing of these works with the Woolston Mainstreet Committee. These discussions had resulted in agreement to delay starting the work until February of the year 2000.

The Board **received** the information.

11.4 WORKING PARTY ON GREEN OPEN SPACE

The Community Advocate gave the Board a verbal update on the discussions held by the working party set up to discuss with other Business Units the purchase of property for green open space.

It is expected that a report would be presented to the next meeting of the Community Board. The Board was also advised that a seminar on this matter would be held on 11 August 1999.

The Board **received** the information.

11.5 2000/2001 ANNUAL PLAN AND BUDGET

The Community Advocate requested the Board to consider establishing a working party to consider a process on how to gather information from the community for input into the 2000/2001 Annual Plan and Budget.

The Board **decided**:

1. To appoint 3 members to a working party to work with the Community Advocate to discuss and design a process to ensure full feedback from the community on issues of concern so that these might be included in the 2000/2001 budget process.
2. That the working party to work with the Community Advocate be the Chairman, Liz McRostie, and Linda Rutland.

11.6 PRESENTATION OF CERTIFICATES TO RETIRING BOARD MEMBERS

At an informal afternoon tea immediately before the commencement of the Board meeting, former Hagley/Ferrymead Community Board members Richard Boulton and David Cox were thanked for their service to the community and presented with framed certificates marking their service to the Hagley/Ferrymead Community Board and to its community.

11.7 TE WHARE ROIMATA – COMMUNITY BOARD VISIT

Members of the Board had sought a visit to Te Whare Roimata. The proposed date for the visit is Thursday 15 July 1999 at 10.00am.

The Board **received** the information.

11.8 ROAD-SIDE VENDING – LINWOOD AVENUE

At its meeting on 3 June 1998, the Community Board had decided to support a review of the now restricted areas for road-side selling, particularly in Linwood Avenue, Main Road and at Scarborough. Various difficulties had prevented the implementation of action on this decision.

The Board **decided** to set up a working party of Linda Rutland, Erin Baker, Derek McCullough, John Freeman and Charles Manning (if he wishes to be involved) to talk to the various Council Business Units to explore the difficulties pertaining to this whole issue.
