The purpose of this report is to obtain Council approval for acceptance of a tender which is above the \$300,000 authority delegated to Council officers.

The contract is for the resealing of the carriageway pavements in various city streets.

Tender prices have been received as follows:

Canroad Construction Limited	\$480,780.10
Fulton Hogan Limited	\$518,216.44
The Isaac Construction Company Limited	\$523,620.59
Works Civil Construction	\$530,558.10

All prices exclude GST.

These prices include a contingency sum of \$10,000 and the work is for a twelve (12) week period.

The estimate for the work was \$500,000.

Mr Richard English of Canroad Construction Limited has given an assurance that the work can be completed within the specified time.

2. WATER, WASTEWATER AND STORMWATER REVIEW

Councillors will be aware that the proposed Central Government review of water, wastewater and stormwater services has recently changed direction with an announcement by the Prime Minister that she has accepted a suggestion from the Metropolitan Mayors that the review be undertaken by local government.

Local Government New Zealand President, Louise Rosson, has addressed zone meetings around the country and received firm support for LGNZ managing the review in consultation with member authorities.

The first step is to obtain agreement with both member authorities and central government on a terms of reference for the review and to this end a draft has been prepared and circulated to local authorities for comment. The deadline for comment has been set as 12 November 1999, which means that Councillor consideration can only occur at Committee level. The Water Services Manager has recommended that a report be prepared for the November meeting of the City Services Committee and that the Committee be given power to make submissions on the Council's behalf.

The draft Terms of Reference are available to Councillors and any comments would be welcomed by the Committee.
