

25. CORRESPONDENCE

25.1 SUMNER REDCLIFFS LYTTTELTON UNION PARISH

The Board considered a letter from the Sumner Redcliffs Lyttelton Union Parish outlining costs for a Christmas Carol event on 13 December, and asking for a contribution to costs.

The Board **resolved** to support this event by providing a grant of \$200 from the 2000/01 Discretionary Fund.

25.2 FRIENDS OF EDMONDS FACTORY GARDENS

The Board considered a letter from Friends of Edmonds Factory Gardens requesting funding for their annual Christmas carol event, to enable them to have a band playing for 2 hours.

The Board **resolved** to support this event by providing a grant of \$150 from the 2000/01 Discretionary Fund.

25.3 AVONSIDE COMMUNITY DAY – JANUARY 2001

The Board considered a letter on behalf of the Avonside Community Group seeking funding for a Community Day in January 2001.

The Board agreed with the underwriting principle and asked the staff to consider criteria/communication for 2001/2002 to try and achieve a fair allocation of Community Day funding.

The Board **resolved** to support this event by underwriting it up to a maximum of \$1,000 from the 2000/01 Discretionary Fund.

The Board **resolved** to support this event by providing a grant of \$1,000 from the 2000/01 Discretionary Fund.

25.7 REPORT ON NEIGHBOURHOOD WEEK CLEAN UP
