

## 1. NEW BRIGHTON MALL - CONSIDERATION OF THE DECISION OF THE CITY SERVICES COMMITTEE

The purpose of this report is to advise the Council of the Burwood/Pegasus Community Board's meeting over the City Services Committee recommendations on the proposal to install a road into New Brighton Mall.

The City Services Committee recommendation has reopened the road issue and given little time for community input prior to a decision being made by the Council. This special meeting was to firstly allow the Board to discuss the issue and also for the community to have some awareness of the recommendations being forwarded to the Council.

At its 31 January 2000 meeting the Board considered a report on the progress of planning for the Mall undertaken by the Environmental Policy and Planning Unit in consultation with the New Brighton Working Party. The focus of these discussions had been over the proposed rejuvenation of the eastern end of the Mall through to Oram Avenue. As the road issue has caused some controversy in the past the Working Party had agreed to focus on developments that were consensual to both the Residents' Association and business representatives. From the New Brighton Mall Progress Report the Board resolved:

- 1. To accept the recommendation of the Working Party that the first priority be improvements to the eastern end of the Mall.*
- 2. That staff be asked to provide a design for the eastern end of the Mall more closely aligned to the current budget.*
- 3. That the Working Party continue to discuss an overview plan for the rejuvenation of New Brighton Mall aligned with the action points.*
- 4. That the New Brighton Mall progress report be sent to the relevant Standing Committees for information only.*

At its Tuesday 8 February meeting the City Services Committee in considering the same report made the following recommendations to the Council meeting:

- 1. That the Council re-establish a one-way road east through the mall to Oram Avenue and that connections to either or both Hawke Street (north) and Beresford Street (south) be investigated.*

2. *That a special rating area be investigated also.*

The Environment Committee also received the report made the following recommendation to the Council:

*To endorse the New Brighton Mall concept Plan for the New Brighton Revitalisation - Oram Avenue to Marine Parade, subject to budgeting approval.*

After considering these recommendations and after some discussion the Board **decided** to make the following recommendations to the Council:

1. That the Council give priority to funding the projects that have the support of the New Brighton Residents' Association, the New Brighton District Business Association and New Brighton Project (Mainstreet).

The motion was moved by Don Rowlands, and seconded by Caroline Kellaway, and when put to the meeting was declared **carried** on division no.1 by nine votes to 0, the voting being as follows:

**For (9):** Glenda Burt, Carole Evans, Gail Sheriff,  
Caroline Kellaway, David Close, Andy Lea,  
David Dobbie, Don Rowlands, Chrissie Williams.

**Against:** Nil

2. That the Community Board ask the Council to defer making a decision on a one-way road through the western end of the New Brighton Mall until:
  - (a) A costed plan has been produced for such a road;
  - (b) The source of funds has been decided, and in particular that part or all of the work be funded by a separate or special rate on the New Brighton businesses;
  - (c) Legal processes regarding reintroducing a road through this section of Seaview Road had been clarified; and,
  - (d) The Community Board asks the Council to defer making a decision until it is clear that the New Brighton Community support a road proposal.

The motion, and amendment (d), were moved by David Dobbie, and seconded by Andy Lea, and when put to the meeting were declared **carried** on division no.2 by five votes to four, the voting being as follows:

**For (5):** Caroline Kellaway, David Close, Andy Lea, David Dobbie, Don Rowlands.

**Against (4):** Glenda Burt, Carole Evans, Gail Sheriff, Chrissie Williams.

(Note: Chrissie Williams, Glenda Burt, Gail Sheriff and Carole Evans requested that their vote against the adoption of the Board's recommendation 2 be recorded.)
