

## 16. CORRESPONDENCE

### 16.1 FUNDING FOR SUMNER PLUNKET TOY LIBRARY

The Board considered a letter from the co-ordinator of the Sumner Plunket Toy Library seeking funding from the Board's Discretionary Fund.

The Board **resolved** to provide a grant of \$500 to support the Sumner Plunket Toy Library from the 2000/01 Discretionary Fund.

### 16.2 REQUEST FOR FUNDING – LINWOOD COMMUNITY CHILDCARE CENTRE INC

The Board considered a request from the Linwood Community Childcare Centre Inc for funding to cover in the nursery and preschool verandah areas to provide more space in winter.

The Board **resolved** to provide a grant of \$1,200 for this project from the 2000/01 Discretionary Fund.

### 16.3 WOOLSTON COMMUNITY LIBRARY – CHILDREN'S SECTION

The Board considered a letter of appreciation of the Year 2000 Fund grant provided by the Community Board for the purchase of new books for the Woolston Community Library Children's Section.

The Board **received** the information.

### 16.4 REDCLIFFS PUBLIC LIBRARY

The Board considered a letter received from the Redcliffs Public Library expressing appreciation for the project fund grant of \$1,000 offered to support this Library.

The Board **received** the information.

### 16.5 COMMUNITY PRIDE GARDEN AWARD

The Board considered a letter of appreciation received from Mr & Mrs L R Sullivan for the Community Pride Garden Award Certificate which they had received.

The Board **received** the information.

### 16.6 GLOBAL YOUNG LEADERS' CONFERENCE

The Board considered a letter received from Joan Letufuga, Principal of the Catholic Cathedral College, seeking funding support for two students to attend the World Global Youth Conference in New York and Washington DC.

The Board **resolved** to provide a grant of \$1,000 to the Catholic Cathedral College Global Youth Conference fund to assist the conference costs of the two students wishing to attend from the 2000/01 Discretionary Fund.

In voting on this resolution there was an equality of votes. The resolution was declared “carried” on the Chairman’s casting vote in favour of this resolution.

#### 16.7 FUNDING FOR COMMUNITY WATCH

The Board considered a letter from Mr Bernard Foley, Treasurer of the City to Sumner Community Watch, seeking funding of \$1,800 towards the running costs of the Community Watch cars. Mr Foley had already addressed the Board in support of this request at an earlier stage of the meeting.

The Board **resolved** to make a grant of \$1,800 to the City to Sumner Community Watch from the 2000/01 Discretionary Fund to meet the running costs of the Community Watch cars.

#### 16.8 FUNDING FOR HEATHCOTE RAIL EMBANKMENT LANDSCAPING

The Board considered a letter seeking funding of \$1,236 from the Heathcote Valley Community Association Inc to support a landscaping project on the railway embankment on either side of the Martindales Road underpass.

The Board **resolved** that a grant of \$1,236 be made to the Heathcote Valley Community Association Inc from the 2000/01 Discretionary Fund for planting of the railway embankment at Martindales Road.
