# 1. CENTRAL PLAINS WATER ENHANCEMENT STEERING COMMITTEE: RATIFICATION OF DECISION TO PROCEED WITH FURTHER WORK

The purpose of this report is to obtain the Council's ratification of the Central Plains Water Enhancement Steering Committee proposal to carry out further feasibility work within the constraint of current funding.

#### BACKGROUND

At the 18 December joint meeting between the Selwyn District Council and the Strategy and Resources Committee of the Christchurch City Council the following resolutions were passed:

- "1. That the parent councils instruct the Central Plains Water Enhancement Steering Committee to proceed with Phase One of Stage Two of the Feasibility Study, as broadly defined in the Terms of Reference included in the Scoping Study Report (Appendix 5) subject to ratification of both councils.
- 2. That the parent councils request the Central Plains Water Enhancement Steering Committee to report back concerning Phases 2 and 3 of Stage 2 of the Feasibility Study with proposals for funding of the remainder of the study."

It will be seen from the first resolution that this Council's ratification is required before the Phase One work proceeds.

#### **PROPOSAL**

The Central Plains Water Enhancement Steering Committee (CPWESC) met on 20 February and recommends the following programme of work as Phase One. This programme absorbs the funding currently available to the committee and as required by the second resolution the CPWESC will report back to the parent councils before work beyond Phase One is undertaken:
