## 2. ALLOCATION OF PROJECT AND DISCRETIONARY FUNDING 2001/02

A report from the Community Secretary identified projects forwarded to the Board for consideration from the 2001/02 Project and Discretionary funding.

## The Board **decided**:

- 1. That in 2001/02, of the \$40,000 SCAP funding available:
  - \$20,000 be allocated to the SCAP Committee subject to a report to the Board meeting on 2 April 2001 on the benefits of having a separate SCAP Fund/Committee and other available options for Board support of community projects.
  - (b) \$20,000 be allocated during the current Project and Discretionary considerations.
- 2. That \$34,950 be retained as a Discretionary fund for Board allocation during 2001/02.
- 3. That the 2001/02 Project funds be allocated as follows:

- 8. That the City Streets Unit be requested to undertake Living Streets projects in both the Burwood and Pegasus wards in areas where roading work is to be done, namely in Saltaire Street and Hampshire Street.
- 9. That the following project proposals be referred to the SCAP Committee for funding consideration:
  - Generations Together Event.
  - New Brighton Project (\$5,000).
  - Wainoni/Aranui Family Centre (\$3,000).
