10. CORRESPONDENCE

10.1 **Donation Washbourne/Brockworth House – Ferrymead Heritage Park**

A letter was received from the Director of the Ferrymead Heritage Park asking the Board whether it wanted a donation the Board made to the Washbourne/Brockworth House project to be returned or put to another project.

The Board **resolved** to request that the donation be returned to the Board.

10.2 Sealed Driveways - Mt Pleasant Community Centre & Ratepayers' Association (Inc)

A letter was received from the President of the Mt Pleasant Community Centre & Ratepayers' Association asking the Board to review the procedure where the Council maintains sealing of driveways from the road to the residents' boundary where there is a footpath but does not where there is no driveway. The Board noted that the City Services Committee reconfirmed this policy in March 2001.

The Board **resolved** to write to the Mt Pleasant Community Centre & Ratepayers' Association (Inc) advising that the previous Council policy has been reconfirmed.

10.3 Intersection Hargood Street and Linwood Avenue - Association of Blind Citizens of New Zealand Inc

A letter was received from the Canterbury Branch of the Association of Blind Citizens requesting that a pedestrian operated crossing be installed at the intersection of Linwood Avenue and Hargood Street.

The Board **resolved** to seek a report for the June 2002 Board meeting as to how the matters raised may be addressed and to advise the Association accordingly.

10.4 Linwood Public Library - Association of Blind Citizens of New Zealand Inc -

A letter was received from the Canterbury Branch of the Association of Blind Citizens of New Zealand Inc requesting that a zebra crossing be placed outside the entrance of the public library in Cranley Street.

The Board **resolved** to seek a report on the issue after staff have discussed the matter with the developers of Eastgate Mall.

10.5 Oak Trees on Bridle Path Road - Heathcote Valley Community Association Inc

A letter was received from the Heathcote Valley Community Association asking the Board to source funding for the undergrounding in Bridle Path Road between Ferrymead Drive and where the houses start in Martindales Road.

The Board **resolved**:

- 1. That respecting budget limitations all possible urgency be given to undergrounding an area of Bridle Path Road between Ferrymead Drive and Martindales Road excepting outside the residential area.
- 2. That the Association be advised of the resolution.

10.6 The Ferrymead Guides - Ferrymead Heritage Park

A letter was received from the Director of Ferrymead Heritage Park requesting funding of \$3,400 for resources and building development.

The Board **resolved** to refer this request from the Ferrymead Heritage Park to the Metropolitan Discretionary Fund.

10.7 Carnival Day - Bromley Community Residents' Inc

A letter was received from the Bromley Community Residents Inc thanking the Board for the funding provided for the Bromley Carnival Day held on 16 February.

The Board **resolved** to receive the letter and congratulate the residents' group for organising what was a very successful event.
