

# 1. PROPOSED ROAD STOPPING – DISPOSAL OF REDUNDANT ROAD WIDENING 43 & 45 MAFFEYS ROAD

The purpose of this report is to recommend to the Council that it start the legal procedures necessary to stop two portions of legal road.

The owners at No. 43 and 45 Maffey's Road have approached the Council and asked if they can purchase the unformed road adjoining the frontage of their properties. The proposed road stopping is not shown in the Notified City Plan.

The stopping of the unformed portions of Maffey's Road was approved in principle by the Council on 12 December as the land is not required for roading purposes.

Negotiations between Council officers and the adjoining land owners have been satisfactorily concluded subject to the successful conclusion of the road stopping procedure. The City Streets Unit agrees with this proposal. The land is not formed as road but is occupied by the adjoining owners. The plan is attached.

The following resolution is necessary to initiate the stopping procedure:

## RESOLUTION

Pursuant to the provisions of Sections 319(h) and 342 of the Local Government Act 1974, the Christchurch City Council hereby resolves to stop these portions of road as shown on the plan and described in the Schedule hereto.

## REASON FOR THE ROAD STOPPING

The Council has received a request from the adjoining owners for the purchase of the land, which is no longer required by the Council for roading purposes.

## PURPOSE TO WHICH THE STOPPED ROAD WILL BE PUT

The portion of road when stopped, will be sold to the adjoining owners pursuant to Section 345(1)(a)(i) of the Local Government Act 1974 and amalgamated with their certificates of title pursuant to Section 345(2) of the Local Government Act 1974.

The land is situated alongside and occupied by No. 43 and 45 Maffey's Road and is 6 metres in width.
