

12. ART GALLERY - PARKING RESTRICTIONS ON WORCESTER STREET, MONTREAL STREET AND GLOUCESTER STREET

The Committee considered a report seeking approval to install new parking restrictions in the three streets surrounding the new Christchurch Art Gallery site as a consequence of the establishment of the Christchurch Art Gallery from May 2003. The report detailed the proposed changes and the reasons for these.

The Committee **resolved**:

1. That the following existing parking restrictions be revoked:
 - (i) On the north side of Worcester Street commencing at its intersection with Montreal Street extending in an easterly direction for a distance of 62.5 metres.
 - (ii) On the east side of Montreal Street commencing at its intersection with Worcester Street and extending to its intersection with Gloucester Street.
 - (iii) On the south side of Gloucester Street commencing at its intersection with Montreal Street and extending in an easterly direction for a distance of 97 metres.

2. That the following parking restrictions be imposed on the north side of Worcester Street:
 - (i) That the parking of vehicles be prohibited, commencing at the intersection with Montreal Street and extending in an easterly direction for a distance of 28 metres.
 - (ii) That the parking of vehicles be restricted to 120 minutes commencing at a point 28 metres from its intersection with Montreal Street and extending in an easterly direction for a distance of 11 metres.
 - (iii) That the parking of vehicles be restricted to 5 minutes at anytime commencing at a point 39 metres from its intersection with Montreal Street and extending in an easterly direction for a distance of 10 metres.
 - (iv) That the parking of vehicles be restricted to 5 minutes at anytime commencing at a point 51.5 metres from its intersection with Montreal Street and extending in an easterly direction for a distance of 11 metres.
 - (v) That a tram stop be installed commencing at a point 5 metres from its intersection with Montreal Street.

3. That the following parking restrictions be imposed on the east side of Montreal Street:
 - (i) That the parking of vehicles be prohibited, commencing at the intersection with Worcester Street and extending in a northerly direction for a distance of 19.5 metres.
 - (ii) That the parking of vehicles be restricted to 120 minutes commencing at a point 19.5 metres from its intersection with Worcester Street and extending in a northerly direction for a distance of 56 metres.
 - (iii) That the parking of vehicles be restricted to 5 minutes at anytime commencing at a point 75.5 metres from its intersection with Worcester Street and extending in a northerly direction for a distance of 6 metres.
 - (iv) That the parking of vehicles be prohibited, commencing at a point 81.5 metres from its intersection with Worcester Street and extending in a northerly direction for a distance of 27 metres.

4. That the following parking restrictions be imposed on the south side of Gloucester Street:
 - (i) That the parking of vehicles be prohibited, commencing at the intersection with Montreal Street and extending in an easterly direction for a distance of 10 metres.
 - (ii) That a bus stop be installed commencing at a point 10 metres from its intersection with Montreal Street and extending in an easterly direction for a distance of 31 metres.
 - (iii) That the parking of vehicles be restricted to 5 minutes at anytime commencing at a point 41 metres from its intersection with Montreal Street and extending in an easterly direction for a distance of 7 metres.
 - (iv) That the parking of vehicles be prohibited, commencing at a point 48 metres from its intersection with Montreal Street and extending in an easterly direction for a distance of 49 metres.
