

# PROPOSED ROAD CLOSURES

It is proposed to close the following roads on the dates and during the times shown, to assist with traffic and crowd control during the ASB Bank Starry Nights and Classical Sparks events to be held in North Hagley Park:

## **Associated Arrangements to apply on both 21 and 28 February**

- Car parking will be available in Hagley Park at a cost of \$3 per vehicle, via the Harper Avenue entrance to Hagley Park.
- The Botanic Gardens car park (off Armagh Street) will be closed to the general public at 5pm
- The Botanic Gardens will close at the earlier time of 6pm.
- The Hagley Park tennis courts will be closed to the general public from 3pm.

## **Wet Weather Arrangements**

In the event of postponements through wet weather, the foregoing closures and associated arrangements will instead apply on the day following each event, ie:

- In the case of the ASB Bank Starry Nights event, they will apply on the following day, Sunday 22 February 2004.
- In the case of Classical Sparks, they will apply on the following day, Sunday 29 February 2004.

## **Right of Objection**

These closures are proposed to be made under paragraph 11(e) of the Tenth Schedule of the Local Government Act 1974. The proposed closures will apply to all vehicular traffic with the exception of emergency service vehicles.
