# PUBLIC NOTIFICATION OF APPLICATIONS FOR RESOURCE CONSENTS

DETAILS of the applications for resource consent listed below may be examined during normal office hours at any of the Council's Service Centre offices. For details of your nearest Service Centre, please telephone 371 1999.

Submissions can be made by notice in writing on Form 6A or to the like effect, and will be received at any Council Office until 5:00pm on Tuesday, 2 April 2002. The address for the Council's Civic Office is P O Box 237, Christchurch. A copy of every submission must also be served on the applicant. Forms for this purpose are available at any Council Office (Town Planning counter).

1. ADDRESS: 336 Avonhead Road – Burnside Park water tower

PROPOSAL: To establish, maintain and operate a telecommunications facility (a mobile phone site) on the Burnside Park water tower. The facility would comprise four panel antennas. These would be attached to the water tower so that the top of the antennas will not extend beyond the top of the tower itself. They would be coloured to match the colour of the tower. A 10 centimetre diameter global positioning system antenna would also be attached to the water tower. Two equipment cabinets would be housed within the water tower.

2. ADDRESS: 336 Avonhead Road – Burnside Park water tower

PROPOSAL: To establish maintain and operate a cellular telephone site on the Burnside Park water tower. The facility would comprise six panel antennas. These would be attached to the water tower so that the top of the antennas will not extend beyond the top of the tower itself. They would be coloured to match the colour of the tower. It would also comprise a 300mm diameter grey microwave dish antenna, which would be attached to the top of the water tower. Three equipment cabinets would be housed within the water tower.

3. ADDRESS: 315 Worsleys Road PROPOSAL: To subdivide 4.929 hectares into six sites, ranging in area from 3590 square metres to 1.23 hectares and to create five additional dwelling sites with associated land based sewage effluent dispersion systems. Land use consent is also sought for the removal of existing pinus radiata trees from the property.

(Note: A notified application for a sewerage discharge permit has also been sought for the five additional dwellings, from Environment Canterbury CRC021179)
