- Any vehicle or specified class of vehicle that has entered the mall under any section of this special order must not be parked for a longer period than is necessary for its driver to carry out his or her business or for the period of any emergency.
- Nothing in this Special Order shall be deemed to prohibit or restrict the use of the mall by any police, fire appliance, ambulance or other vehicle where it is necessary for that appliance or ambulance or other vehicle to enter the mall or portion thereof for the protection of human life or

- [#] SPAYED/NEUTERED DOGS. Evidence in the form of a veterinary certificate, or a declaration from the owner to the effect that the dog is spayed or neutered will be required, where the fact is not already recorded on the Council's dog register.
- [##] A DOG CLASSIFIED AS DANGEROUS, is a dog so classified under section 31 of the Dog Control Act 1996.
- [###] 'ALL OTHER DOGS', are dogs not included in the specific categories above of Responsible Dog Owner Status, Neutered/Spayed dogs, Dangerous dogs, Hearing Ear dogs, Companion dogs, or Guide Dogs for

NOTE: Where the Responsible Dog Owner Status is held by an owner, failure to register by the due date (on or before the 30 June) will cause the status to be lost and the owner will be disqualified from obtaining such status for two years. Fee concessions will not apply after 30 lune.

8. APPLICATION TO REGISTER A DOG:

The Dog Control Act 1996 provides that every person who owns a dog shall make an application to the Council in whose district the dog is ordinarily kept, to register the dog not later than the 1st day of every registration year. The 2002/2003 registration year begins on 1st July 2002.

Application to register a dog must be made on the form provided by the Council and signed by the owner, or his/her agent. Forms have been mailed to all known dog owners.

- (a) Where an unregistered dog is purchased or otherwise acquired, the application to register the dog shall be made forthwith or, on or before the date on which the dog attains the age of 3 months, whichever
- (b) Details necessary for application:
 - (i) Name, address, date of birth and telephone number of the owner of the dog
 - (ii) Address at which the dog is ordinarily kept
 - (iii) Description of the dog including the name, breed, colour, age, sex (including whether the dog is neutered or not), and any distinguishing marks
 - (iv) A description of any tattoo or other permanent identification on the dog.

No dog is deemed to be registered until the appropriate fee has been paid in full and a receipt and disc

- (c) No fees are payable in respect to any transfers of ownership, or changes of address, however notification in writing of such changes is required within 14 days.
- Where any dog is required to be registered under Clause 8(a) on or after the 1st day of August in any year, the fee payable shall be one twelfth of the appropriate annual fee for each complete month remaining in the registration year after the date of such requirement.

o. REFUND ON DEATH OF DOG:

- (a) A declaration, with evidence of the death, is necessary in respect of all claims made under subclause 9(b). Declaration forms may be obtained from any Council Service Centre.
- Where the fee for the registration of any dog for any year is paid and the dog dies before the commencement of, or during that year, the Council will refund upon written request, a portion of the fee. In the case of a dog that dies before the commencement of the year, the refund would be the full fee paid, and in the case of a dog that dies during the year, the appropriate part of that fee. The part fee refundable is one twelfth of the fee paid for each complete month remaining in the registration year afte the date on which the application for refund is received.
- (c) Where a registered dog is transferred from one district to another within New Zealand, the registration remains in force. No refund is made as a result of the transfer, and the dog is not required to be reregistered in the new area until 1 July next.
