



## NOTICE OF PROPOSED TEMPORARY ROAD CLOSURES

It is proposed to temporarily close the following roads for the period shown, during the Coca Cola Christmas in the Park event to be held in North Hagley Park:

### Roads Proposed to be Closed

Park Terrace and Rolleston Avenue between Kilmore Street and Gloucester Street

Chester Street west between Park Terrace and Cranmer Square

### Proposed Periods of Closure

The roads listed above are proposed to be closed to vehicular traffic between 6pm and 11pm on Saturday 30 November 2002.

In the event of wet weather, the event will be postponed for 24 hours and will instead be held between 6pm and 11pm on Sunday 1 December 2002.

These closures are proposed to be made under paragraph 11(e) of the Tenth Schedule of the Local Government Act 1974, and will apply to all vehicular traffic with the exception of emergency service vehicles.

## NOTICE OF TEMPORARY CLOSURES FOR MULTISPORT RACE

## NOTICE OF PROPOSED TEMPORARY ROAD CLOSURES: NEW BRIGHTON

The Council has received an application for the temporary closure of the following roads during the period shown, during the holding of the New Brighton Christmas Parade:

Shaw Avenue (Hawke Street to Seaview Road)

Seaview Road (Shaw Avenue to Marine Parade)

### Proposed Period of Closure

Between 10.45am and 11.15am on Saturday 14 December 2002

The roads listed above will be closed for the purposes of controlling traffic to allow the event to take place. Temporary traffic delays may be experienced during the closure period.

During the closure drivers must obey any instructions given by event controllers and Police Officers.

This closure is proposed to be made under paragraph 11(e) of the Tenth Schedule of the Local Government Act 1974 and will apply to all vehicular traffic with the exception of emergency service vehicles.

## NEW YEAR'S EVE EVENTS: PROHIBITION OF VEHICLES AND

- (d) The transport of liquor from premises on land having a frontage to the public place concerned if:
  - (i) The liquor has, under the Sale of Liquor Act 1989, been sold on the premises for consumption off the premises; and
  - (ii) The liquor is promptly removed from the public place.
- (e) The transport of liquor from outside the public place concerned for delivery to premises on land having a frontage to the public place concerned if:
  - (i) The liquor may, under the Sale of Liquor Act 1989, be sold on the premises; and
  - (ii) The liquor is promptly removed from the public place.
- (f) The driving or riding of a motor vehicle by a person residing in premises on land having a frontage to the specified public places or by his or her bona fide visitors.
- (g) Buses, taxis, emergency service vehicles or Council vehicles.

### POWERS OF POLICE

1. A member of the police may, without a warrant exercise the following powers under the relevant provisions of the Local Government Act 1974:
  - (a) Arrest a person whom the member of the police finds committing an offence against section 709G.
  - (b) While a prohibition is in force, arrest a person whom the member of the police has reasonable cause to suspect of having committed an offence against section 709G.
2. A member of the police may, without a warrant, search:
  - (a) A vehicle in, entering, or about to enter a public place, in respect of which a prohibition under 1 or more of paragraphs (b) to (d) of section 709C(2) is in force, for the purpose of ascertaining whether or not the vehicle contains liquor.
  - (b) A container (for example, a parcel, package, bag, or case) in the possession of a person who is in, entering, or about to enter a public place, in respect of which a prohibition under 1 or more of paragraphs(b) to (d) of section 709C(2) is in force, for the purpose of ascertaining whether or not the container contains liquor.
3. Before exercising the power of search in subsection (2), a member of the police must:
  - (a) Inform the person in possession of the vehicle or container of the provisions of subsection (4); and
  - (b) If the person is in possession of the vehicle or container in the public place, give the person a reasonable opportunity to remove the vehicle or container from the public place.
4. A member of the police must not exercise the power of search in subsection (2) if the person in possession of the vehicle or container removes it from, or refrains from taking it into, the public place concerned.
5. A member of the police may seize and remove liquor and its container or any other container that the member of the police has reasonable cause to believe would be evidence of the commission of an offence against section 709G.
6. Liquor or a container seized under subsection (5) is forfeited to the Crown if the person from whom the liquor or container is seized is convicted of an offence against section 709G.

### PENALTY

Every person commits an offence and is liable on summary conviction to a fine not exceeding \$500 who, knowing that a prohibition is in force, contravenes the prohibition.

The proposed prohibitions will be submitted to an ordinary meeting of the Council to be held on Thursday 12 December 2002, for confirmation.

## CHRISTCHURCH CITY RURAL FIRE AREA NOTICE OF RESTRICTED FIRE SEASON

(IMPOSED PURSUANT TO SECTION 22(2) OF THE FORESTS AND RURAL FIRES ACT 1977)

Notice is hereby given that pursuant to Section 22 (2) of the Forest and Rural Fires Act a restricted fire season is imposed by the Christchurch City Council over the rural area for which the Council is the Fire Authority under the Forests and Rural Fires Act 1977, for the period 1 November 2002 to 28 February 2003 (inclusive).

The rural area for which the Council is the Fire Authority under the Forest and Rural Forest Act 1977 covers all of the district administered by the Council as territorial authority pursuant to the Local Government Act 1974 (ie the City of Christchurch) except:

1. Bottle Lake Rural Fire District; and
2. Chaney's Rural Fire District; and
3. The Christchurch Fire District established under to the Fire Services Act 1975; and

Hawke Street (Marine Parade to Shaw Avenue)  
Shaw Avenue (Hawke Street to Seaview Road)

**NEW YEAR'S EVE EVENTS:  
PROHIBITION OF VEHICLES AND  
CONSUMPTION OF LIQUOR**

At its meeting on 24 October 2002 the Christchurch City Council gave its preliminary approval for the following road closures and liquor prohibitions for the forthcoming New Year's Eve celebrations to be held in and around Cathedral Square and in the vicinity of Spencer Park.

**SPENCER PARK**

**Specified Days and Times During Which Prohibited Acts Will Apply**

Between the hours of 6pm on Tuesday 31 December 2002 and 6am on Wednesday 1 January 2003.

**Specified Public Places in Vicinity of Spencer Park**

At Spencer Park situated on the southern side of Heyders Road, commencing from 71 Heyders Road, Spencerville and continuing to the beach access and including car parking areas.

**CATHEDRAL SQUARE**

**Specified Days and Times During Which Prohibited Acts Will Apply**

Between the hours of 8.30pm on Tuesday 31 December 2002 and 1am on Wednesday 1 January 2003.

**Specified Public Places in and Around Cathedral Square**

Worcester Boulevard between Rolleston Avenue and Cathedral Square

Worcester Street between Cathedral Square and Manchester Street

Colombo Street between Hereford Street and Gloucester Street

Tramway Lane from Worcester Street to Hereford Street

Oxford Terrace between Armagh Street and the Bridge of Remembrance on the western side of the eastern kerbline

Strand Lane

Press Lane

**ACTS PROHIBITED IN FOREGOING PUBLIC PLACES**

The following acts are prohibited in the specified public places during the specified days and times:

1. The use of ordinary vehicular traffic.
2. The consumption of liquor.
3. The bringing of liquor into the specified public places.
4. The possession of liquor.

**EXEMPTIONS FROM PROHIBITIONS**

The prohibitions exclude:

- (a) The use of a vehicle by a person residing in premises on land having a frontage to the public place concerned or by genuine visitors of the person.
- (b) The transport of liquor from premises on land having a frontage to the public place concerned if:
  - (i) The liquor is being delivered by a person residing on the premises or by the person's genuine visitors to a place outside the public place; and
  - (ii) The liquor is promptly removed from the public place.
- (c) The transport of liquor from outside the public place concerned if:
  - (i) The liquor is being delivered to a person residing on premises having a frontage to the public place or to the person's genuine visitors; and
  - (ii) The liquor is promptly removed from the public place.

**CHRISTCHURCH CITY RURAL FIRE  
AREA NOTICE OF RESTRICTED FIRE  
SEASON**

**(IMPOSED PURSUANT TO SECTION 22(2) OF THE FORESTS  
AND RURAL FIRES ACT 1977)**

Notice is hereby given that pursuant to Section 22 (2) of the Forest and Rural Fires Act a restricted fire season is imposed by the Christchurch City Council over the rural area for which the Council is the Fire Authority under the Forests and Rural Fires Act 1977, for the period 1 November 2002 to 28 February 2003 (inclusive).

The rural area for which the Council is the Fire Authority under the Forest and Rural Forest Act 1977 covers all of the district administered by the Council as territorial authority pursuant to the Local Government Act 1974 (ie the City of Christchurch) except:

1. Bottle Lake Rural Fire District; and
2. Chaney's Rural Fire District; and
3. The Christchurch Fire District established under the Fire Services Act 1975; and
4. State areas.

Please Note:

1. The restriction does not apply to barbeques (in enclosed containers) lit on a property serviced by a domestic water supply.
2. During a restricted fire season it is an offence to light any fire in the open air unless a permit has been obtained from the Christchurch City Council. Applications for permits may be made to the Parks and Waterways Unit, Civic Offices, 163 Tuam Street, Christchurch (telephone 372-2840).
3. Any permit issued is not a legal defence to claims for damage which may arise from the fire. The responsibility for its control and the liability for any damage which might arise lies with the person lighting the fire.

**NOTICE OF PROHIBITION ON FIRES IN  
THE OPEN AIR WITHIN THE WHOLE  
OF THE CITY OF CHRISTCHURCH**

**(IMPOSED PURSUANT TO CLAUSE 8 OF THE CHRISTCHURCH  
CITY FIRES BYLAW 1991)**

Notice is hereby given that the prohibition over the whole of the City of Christchurch on fires in the open air is imposed by Clause 5 of the Christchurch City Fires Bylaw 1991 for the period 1 November 2002 to 28 February 2003 (inclusive).

During any such prohibition no person shall light any fire in the open air and no person being the occupier of any premises shall cause, permit, or suffer any such fire to be lit there or to continue to burn there. The penalty for such an offence is a fine of up to \$500.00.

The prohibition applies to all of the district administered by the Christchurch City Council as territorial authority pursuant to the Local Government Act 1974 (ie all of the City of Christchurch).

The purpose of the prohibition is to conserve public safety by preventing danger from fire.

Note: The Council may at any time, where in its opinion special reason exists or may exist to prevent the outbreak or spread of fire, prohibit the lighting of fires in the open air for any specified additional period of time within the whole or any specified part of the city.

Please Note: This prohibition does not apply to:

1. Any barbeque or hangi provided -
  - (a) it is not likely to constitute a danger to any person or property by reason of its location, risk of spread, inadequate containment, prevailing wind or otherwise; and
  - (b) there is immediately available a pressurized water supply connected to a hose; and
  - (c) it is adequately supervised.
2. Any fire in the open air in respect of which the occupier of the land upon which the fire is situated has obtained from the Council an exemption from the prohibition or an authority or permit issued under the Forests and Rural Fires Act. Exemptions may only be granted for commercial activities. Applications for exemptions may be made at the Environmental Monitoring Unit, Civic Offices, 163 Tuam Street, Christchurch.

(The issue of an exemption is not a legal defence against claims for damage arising by reason of the fire. The responsibility for its control and liability for any damage which may arise lies with the person lighting the fire.)
