



AUTHORISED DRAINLAYERS REGISTER

The Christchurch City Council proposes to establish an authorised drainlayers register. By February 2003, only authorised drainlayers will be permitted to undertake drainage work involving:

- construction of connections to public drains for new private drains
- construction of new private drains in roads
- renewal of public drains under proposed building works
- diversion of public drains around proposed building works
- repair of private drains in roads.

COMMUNITY DEVELOPMENT SCHEME COMMITTEE MEMBERSHIP

The Christchurch City Council administers its Community Development Scheme Funds through seven distribution committees. Six of these committees are based within the six Community Board areas (Community Funding Committees) and consider applications from local organisations and the other committee (Metropolitan Funding Committee) considers applications from organisations providing metropolitan citywide services.

The Council is now calling for nominations for community representatives on the committees to join the Council and Community Board elected members.

Community Representatives should (ideally) have:

- Interest and involvement in community issues/groups.
- Some experience in committee processes.
- Knowledge of various communities of interest.
- The ability to be articulate and assertive.

The term of office is for three years and is on a voluntary basis.

The commitment varies but should be approximately 15-30 hours per year.

The Council/Community Board will appoint committee members so as to reflect the local community social make up with representation from relevant special population groups.

Representation from the local Maori community will be included on each committee.

Nominations close at 4 pm on Friday 13 December 2002 and should be submitted on the application/nomination form available from the Civic Offices, Tuam Street or from your local Christchurch City Council Service Centre.

NOTICE OF LOCAL BILL - CHRISTCHURCH CITY COUNCIL (ROBERT MCDUGALL GALLERY) LAND VESTING BILL

Notice is given that the Christchurch City Council intends to introduce into the House of Representatives the above named Bill.

The objects of the Bill are:

1. To vest land on which is situated the Robert McDougall Art Gallery, in the Christchurch City Council free from all trusts, restrictions and reservations for the Council to hold as a local purpose reserve for the purpose of a gallery for the display of art and decorative arts and crafts and ancillary purposes.
2. To empower the Council to lease, licence or let all or any part of the land on such terms and conditions as it thinks fit for the purpose stated in paragraph 1.
3. To repeal section 54 of the Reserves and others Lands Disposal and Public Bodies Empowering Act 1925.

LOCATION	NATURE OF OPERATION
Adjacent to the causeway, north side	Manual and/or suction hose moved manually at low tide.
McCormacks Bay	Manual at low tide and/or collection net pulled to shore at high tide. Portable heat treatment unit at low tide.
Humphreys Drive from Tidal View to windsurf parking area	Manual and/or suction hose moved manually and/or excavator or loader operating from the top of the sea wall at low tide. Collection net pulled to shore by boat or amphibious craft at high tide. Set net staked to the estuary bed, projecting no more than 20m into the estuary (measured perpendicular to the shore).
Mid-estuary	Amphibious "light footprint", balloon-tired vehicle and/or hovercraft access at low tide. Manual operation including portable heat treatment unit at low tide
