#### 9.7 Diverse Café

Diverse Cafe, run for and by young people in Linwood, was the supreme award winner at this year's Youth in Local Government conference.

The café was a finalist in all four awards categories. It won the Youth Participation category and was also picked from the four winners as the supreme Sprit of Youth Pu Maia Rangatahi award.

Diverse, opposite Eastgate Mall at 5 Buckleys Road, opened in April 2003. It was an idea developed by young people in the area after research for the Board suggested the community was concerned about its younger members. The Youth Initiatives Trust was formed as the ownership body and a committee of 14 to 20-year-olds has managed the venture with financial support of \$20,000 per annum from the Board's Strengthening Communities Fund.
