#### 2. ENVIRONMENT CANTERBURY'S DRAFT COMMUNITY PLAN – BOARD SUBMISSION

The opportunity was available for the Board to formulate a submission on the contents of Environment Canterbury's draft community plan for the period 2004-2014.

# 3. "OUR COMMUNITY PLAN - CHRISTCHURCH O-TAUTAHI 2004 - 2014" - ADDENDUM TO BOARD'S SUBMISSION

The Board Chairman and Community Advocate jointly reported on a meeting convened by rural ratepayers on 14 May 2004 in response to the Council's intention to implement a rule covering rating on some rural properties.

### 5. ORANA WILDLIFE TRUST - REQUESTS FOR FUNDING TRANSFER

With the near completion of the footpath upgrading programme, the Trust had asked the Board to consider transferring its 2004/05 project funding support of \$10,000 to allow a start to be made on their road upgrade project.

**Recommendation:** That the Board's 2004/05 project funding allocation of \$10,000 to Orana Wildlife Trust be utilised towards their road upgrading project.
