
Lisa Mora: Inner City Research

Lisa Mora (Community and Family Division of Anglican Care) presented the findings of her holistic community development project/research, entitled:

- 1 Agency/Organisation Interviews Part 1; and
- 2. "Streeties" (Perspectives, Aspirations and Challenges).

This research was initiated in April 2002 by the Richmond Fellowship in conjunction with the Family and Community Division of Anglican Care.

Following the completion of the research, an interested group of agencies began to explore the establishment of a daytime drop in centre for the homeless population in Christchurch to address multiple issues identified in the research.



An Interagency Partnership Agreement is being signed by those agencies/organisations interested in establishing an Inner City Interagency Community Development Trust.

Greenspace Area Advocate: Riverside Plantings
