#### 11.4 COMMUNITY DEVELOPMENT ADVISER'S UPDATE ON DALLINGTON COMMUNITY CENTRE

At its meeting on 12 December 2003, the Dallington Community Project Committee requested that the Community Development Adviser review the Dallington Community Centre initiative in order that the Board can assess progress and the need for further support of the Trust. An interim review was undertaken in April 2004 and the centre is on track for setting up acceptable and accountable financial and operational systems.

There have been meetings held at least monthly (initial meetings were weekly) and minutes of all meetings have been taken. Anita Hindmarsh is the Chairperson of the Trust and Jayne Cummins acts as the secretary. Both currently oversee financial matters and the Trust is confident of taking over the lease of the premises from Anglican Care when it comes up for renewal. Volunteer numbers have remained constant at around 40 and a seniors and walking group have been set up. Craft demonstrations and different craft focuses at the centre are offered and advertised in the residents' newsletter. The residents' association has offered to provide a community noticeboard for the centre and the Trust has invited the association to take on this project. The Dallington folk art group is also supported by the Trust. After the completion of a historical display for the centre and a volunteers' social event has been arranged, the next project is a gardening group to help out Dallington neighbours.

A full review of the centre will be undertaken in June and a report is expected to be made to the Board in August 2004. The report will include residents' association feedback and Trust minutes and financial reports will be made available.
