Spencer Beach Holiday Park offers a wide range of accommodation options as can be seen from the schedule above. The proposed new charges for camp sites are still below those of other similar camping grounds in the area. The charges for accommodation are similar to other camping grounds and are respective of the standard of the facilities available. Costs have risen significantly in recent years with increases in electricity and basic maintenance and compliance costs. The lessee has also undertaken a programme of upgrading the accommodation facilities over the past few years as previously reported.
