## 12. STYX MILL COUNTRY CLUB SUBDIVISION: GIVE WAYS AND NO STOPPING RESTRICTIONS

The purpose of this report is to seek the Board's approval to install "Give Way" signs in Watermill Boulevard, Riverbank Road, Brookfield Drive, and "No Stopping" Parking Restrictions in Watermill Boulevard and Hussey Road in the Styx Mill Country Club subdivision. (see attachment)

This subdivision is located at the eastern end of Hussey Road, Northwood and is now being opened for housing development. As part of the development "Give Way" controls are required to be installed at the intersection of Watermill Boulevard and Hussey Road, and on the eastern approach of Riverbank Road and the western approach of Brookfield Drive to Watermill Boulevard.

Because Broomfield Drive and Riverbank Road are a cross intersection with Watermill Boulevard the Give Ways will determine right of way. The "Give Way" sign at Hussey Road will remove the confusion between right turning vehicles and make the intersections safer for through traffic on Hussey Road. The installation of the "No Stopping " restrictions will ensure the intersection is kept clear of parked vehicles, making it safer for all road users

Staff Recommendation:		That the Board approve the installation of the following "Give Way" controls and "No Stopping" Restrictions.	
	1.	That a "Give Way" sign be placed against Riverbank Road east approach at its intersection with Watermill Boulevard.	
	2.	That a "Give Way" sign be placed against Brookfield Drive west approach at its intersection with Watermill Boulevard.	
	3.	That a "Give Way" sign be placed against Watermill Boulevard at its intersection with Hussey Road.	
	4.	That the stopping of vehicles be prohibited at any time on the west side of Watermill Boulevard commencing intersection with Hussey Road and extending in a northerly direction for a distance of 20 metres.	
	5.	That the stopping of vehicles be prohibited at any time on the north side of Hussey Road commencing intersection with Watermill Boulevard and extending in a westerly direction for a distance of 10 metres.	
	6.	That the stopping of vehicles be it intersection with Hussey Road and extending in a northerly direction for a distance of 15 metres.	
	7.	That the stopping of vehicles be prohibited at any time on the north side of Hussey Road commencing at it intersection with Watermill Boulevard and extending in a easterly direction for a distance of 12 metres.	
	8.	That the stopping of vehicles be prohibited at any time on the south side of Hussey Road commencing at a point 18 metres east of an extension to the eastern kerb line of Watermill Boulevard and extending in a westerly direction for a distance of 43 metres
