#### PURPOSE OF REPORT

1. The purpose of this report is to seek the Board's approval to an application for funding from its 2005/06 Youth Development Fund.

#### EXECUTIVE SUMMARY

2. Funding is being sought by Olivia Robin, a 16 year old girl who lives in the Ilam area, towards costs associated with representing New Zealand at the World Irish Dancing Championships being held in Belfast, Ireland from 31 March-29 April 2006.

#### FINANCIAL AND LEGAL CONSIDERATIONS

3. There are no legal issues to be considered. The following outlines budgetary requirements for 2006:

4. Olivia has currently raised \$2,000 through her individual fundraising efforts. This has involved busking, selling chocolates, sausage sizzles and saving money from her part time job. Olivia is unable to apply to most trusts for funding because as an individual she does not meet their criteria.

#### BACKGROUND ON THE YOUTH DEVELOPMENT FUNDING REQUEST

- 5. Olivia has been dancing since she was eight years old. She first represented New Zealand when she was 14 years old at the 2003 Australasian Championships. In 2004 Olivia attended the World Championships and was placed 81<sup>st</sup> in her age group. Olivia is currently ranked first in New Zealand for 16 year olds. Olivia is hoping to place this year in the top 50 competitors.
- 6. Olivia's main goal for attending the World Championships is to further develop her dance knowledge. Olivia is currently a voluntary teaching assistant, teaching on average twice a week. Olivia teaches up to five girls at a time, focussing on new steps and choreography. The World Championships will not only enhance and develop her dancing ability, but also benefit the children she helps to teach each week. Olivia's ultimate goal is to attend a dance school in Ireland and join a dance troupe.
- 7. These are the 36<sup>th</sup> World Championships and are being hosted by the An Coimisiun Lay Irnci Gaelacha (Irish Dancing Commission). To date, the following countries have indicated they will be attending: Ireland, England, Scotland, Wales, USA, Canada, Australia, New Zealand, South Africa and Continental Europe.

8. Olivia received \$400 from the Board's Youth Development Scheme in February 2004. The money was used towards the costs of attending the World Championships 2004.

#### STAFF RECOMMENDATION

It is recommended that the Board allocates \$300 from its 2005/06 Youth Development Fund to assist with costs associated with the applicant travelling to Ireland to represent New Zealand in Irish dancing at the World Championships being held in Belfast from 31 March-29 April 2006.

#### 3. REQUEST FOR FUNDING – SOCKBURN SWIMMING CLUB

#### PURPOSE OF REPORT

1. The purpose of this report is to seek the Board's approval to an application for discretionary funding from the Sockburn Swimming Club. The Club is requesting \$3,376 to replace teaching and office equipment that was destroyed in a fire at its club rooms at Sockburn Pool.

#### EXECUTIVE SUMMARY

- 2. The Sockburn Swimming Club is seeking funding of \$3,376 to replace equipment lost in a fire when its club rooms and contents were totally destroyed on 25 May 2005. The club rooms were based on top of the plant room overlooking Sockburn Pool. All equipment, trophies and records were lost. Each year the Sockburn Club paid an insurance fee to the Council in the belief its club rooms and contents were fully insured under the Council's insurance policy. Regrettably, this was not the case and only the building was insured. The Club has received a payment for the building which it is hoping to invest in another club rooms once the future of Sockburn Pool is apparent.
- 3. The Club was established in 1964 and had its club rooms built at Sockburn Pool when it opened in 1965. The Club currently works with approximately 100 children per year, utilising 15 coaches. Primarily, the Club offers a learn to swim programme for children aged 4 years upwards. Swimming lessons are given by volunteer coaches and the Club has significant involvement in the development of new coaches. Club fees are kept to a minimum to ensure the activity is affordable for families. Most families indicate that they joined the Club because of the family friendly atmosphere and the cost of term subscriptions.
- 4. "Drowning is a very real issue which affects all communities in New Zealand. Drowning is the third highest cause of unintentional death in New Zealand, surpassed only by road vehicle crashes and accidental falls. However, internationally, New Zealand has one of the highest rates of drowning in the developed world. Twice as many New Zealanders, per capita, lose their lives annually through drowning as Australians" (Water Safety New Zealand). Current Water Safety research indicates that only 23% of children under the age of 12 can swim more than 200 meters.
- 5. The proposed replacement of swim equipment will enable the Club to offer a quality learn to swim programme to its members.

#### FINANCIAL AND LEGAL CONSIDERATIONS

6. Sockburn Swimming Club has advised that funds on hand are required for ongoing pool hire costs and the eventual relocation of its club rooms.

#### OPTIONS

- 7. In relation to this application the Board could choose to:
  - (a) Fully fund as requested
  - (b) Partially fund the swimming equipment
  - (c) Decline the application.

#### STAFF RECOMMENDATIONS

It is recommended that the Board approve a grant of \$3,376 to the Sockburn Swimming Club from its 2005/06 Discretionary Fund for the replacement of teaching and office equipment lost in a recent fire at its clubrooms.

#### CHAIRPERSON'S RECOMMENDATION

- (a) That the staff recommendation be adopted.
- (b) That the Board request staff to undertake appropriate action to encourage community recreation groups to check the insurance cover arrangements for their facilities/equipment.

# 4. FUNDING APPLICATION FROM KIDSFIRST KINDERGARTEN LADY MAY FOR COSTS TOWARDS THE REDEVELOPMENT OF THE OUTSIDE PLAY AREA

#### PURPOSE OF REPORT

1. The purpose of this report is to provide information relating to an application by Kidsfirst Kindergarten Lady May for funding of \$10,000 for the redevelopment of their outside playground, from the Board's 2005/06 Community Initiatives Fund, of which there is currently a balance of \$47,000.

#### EXECUTIVE SUMMARY

- 2. Kidsfirst Kindergarten Lady May was established in 1957. It operates under the umbrella of the Canterbury Westland Free Kindergarten Association. Located at 11 Haynes Avenue, Upper Riccarton, it is the only donation based 'pre-school' in the area. The kindergarten caters for children and families from diverse backgrounds. Fourteen different cultures currently attend the kindergarten, with many families being from new migrant and/or refugee backgrounds. At least one third of the families are on limited incomes, which makes fundraising very difficult.
- 3. It has been at least 20-30 years since there has been major redevelopment of the playground. According to the Kindergarten Committee the current playground is unattractive, outdated and challenges current safety standards. The Kindergarten Committee is keen to commence the first stage of a 5-10 year redevelopment plan, which will enable the kindergarten to provide a safer, challenging, and more enjoyable outside play area for the children. The plan has been professionally designed by Edge Landscape Projects Limited. The design and costs associated with each stage of the redevelopment project are attached to this report. Pictures of the current playground area have also been provided.

#### FINANCIAL AND LEGAL CONSIDERATIONS

- 4. There are no legal issues to be considered. The total cost of the plan is \$98,482.50. The redevelopment of the playground will take place in stages so that one area can be redeveloped independent of the others, whilst allowing the remaining playground to operate in its current condition. So far the parents have raised \$9,200 towards this project. Riccarton Rotary has given a grant of \$10,000 and the Committee is also applying to the Lion Foundation, the Scottwood Trust and the J.R McKenzie Trust.
- 5. Kidsfirst Kindergarten Lady May has previously received funding from the Riccarton Wigram Community Development Fund for the following.

## BACKGROUND ON FUNDING APPLICATION FROM KIDSFIRST KINDERGARTEN LADY MAY FOR COSTS TOWARDS THE REDEVELOPMENT OF THE OUTSIDE PLAY AREA

- 7. Kidsfirst Kindergarten Lady May was established in 1957 and operates under the umbrella of the Canterbury Westland Free Kindergarten Association. The main objective of the kindergarten is excellence in early childhood education. Based at 11 Haynes Road, Upper Riccarton, the kindergarten is an education, learning and care facility providing for pre-school children and their families in the local community. One hundred families are enrolled at the kindergarten.
- 8. Kidsfirst Kindergarten Lady May is the only Kidsfirst Kindergarten servicing the Upper Riccarton/Sockburn areas and is the only donation based pre-school in the area. It is a low socio-economic kindergarten and caters for children and families from diverse backgrounds and cultures. There are currently fourteen different cultures attending the kindergarten with many families being from new migrant and/or refugee backgrounds. Kidsfirst Kindergarten Lady May plays an important role in the community as it is often the first initial contact a family has with an educational organisation. The kindergarten sees itself as a place where children from the local community can come together to learn and build relationships and friendships. The kindergarten is very proactive at providing opportunities for children and families and participates in a great number of activities. Some of their recent achievements are as follows:
  - First equal in the Heart Foundation's 5+ a day competition
  - Second in the Push Play Awards
  - Heart Foundation's Healthy Heart Award
  - Parent lunches and Multi-Cultural Celebrations
  - Kindy Dance and Trikeathon
  - Successful Open Day as part of the Neighbourhood Awareness Week attended by approximately 100 visitors.

- 9. The Kindergarten Committee (comprising 10 members) has identified a need to redevelop the playground and outdoor area. According to the Committee the present playground is unattractive, very old and outdated and challenges current safety standards. The Committee recognises that this is a huge undertaking for a low-socio economic kindergarten and is prepared to carry out the project in stages over a number of years. The Committee felt it was important to ensure a professional result and therefore contracted a landscape architect, Grant Edge of Edge Landscape Architects, to redesign the playground and also act as project manager. The plan was presented to the Canterbury Westland Free Kindergarten Association for approval on 9 November 2005. The Association considered the plans from all aspects including financing, safety, and operational aspects, and gave its approval on 14 December 2005. The Association also approved the improvement of the street frontage.
- 10. The first priority for the playground is the stage called Flexible Play Space, and the area in front of the mound in the grass mound area, where the swings are to be relocated. A large willow tree was removed recently due to rot, and as a result, the kindergarten lost a large amount of shade. Once this stage has been completed the Committee hopes to complete the adjoining area known as the grass mound area. The total cost (from initial estimates) for this first stage is \$27,000. The Committee hopes to reduce this to \$20,000 + GST by providing voluntary labour and the use of contacts for materials. Over the Christmas holidays the Committee aims to redevelop the street frontage. This stage is budgeted at approximately \$3,000. A working bee has been planned in order to reduce the cost to \$1,200.
- 11. As Lady May is a low socio-economic kindergarten, fundraising is very difficult. Fundraising activities this year raised approximately \$5,000 for costs associated with the actual running of the kindergarten. The families have also raised \$9,200 towards the redevelopment of the play area. Every family was given tickets to sell. Between forty and fifty families sold all their tickets (20 tickets at \$2 each), and volunteers canvassed shops, malls and pubs. This was a major achievement and the parents need to be congratulated for their efforts. As well as applying to other funders the Committee and families will continue with their fundraising activities in 2006, in order to reach their goal.
- 12. The benefits of the redevelopment of the outside play area are:
  - An outdoor area that is safe
  - An outdoor area that meets early childhood requirements
  - An outdoor area that extends children in their play
  - An outdoor area that is aesthetically pleasing and inviting to children and their families
  - An outdoor area that encourages physical and creative play
  - Engaging families in a united project
  - Networking and relationship building between parents and the local community
  - Enhancing the visual appearance of the Kindergarten and making it more inviting for new families.
- 13. Supporting the redevelopment of the playground links with the following LTCCP Outcomes:
  - A City of Inclusive and Diverse Communities
  - A Learning City
  - A Healthy and Active City.

#### OPTIONS

- 14. The Riccarton/Wigram Community Services Committee agrees to allocate \$10,000 from the Board's 2005/06 Community Initiatives Fund towards the redevelopment of the Lady May Kindergarten outside play area.
- 15. The Riccarton/Wigram Community Services Committee declines the application for funding assistance towards the redevelopment of the Lady May Kindergarten outside play area.

#### PREFERRED OPTION

16. The preferred option is to grant the Lady May Committee \$10,000 towards the redevelopment of the outside area. This is a low socio-economic area, and the families have already worked extremely hard to raise some of the funds for this project. The Committee has been very thorough in its approach to ensure that the redevelopment is done in a professional way. The treasurer of the Committee, who is a chartered accountant, is keeping a tight and accurate record of all monies involved and is actively seeking funding assistance from a range of sources.

#### STAFF RECOMMENDATIONS

It is recommended that the Riccarton/Wigram Community Services Committee agree to grant Kidsfirst Kindergarten Lady May \$10,000 from its 2005/06 Community Initiatives Fund towards the redevelopment of the outside play area.

#### CHAIRPERSON'S RECOMMENDATION

That the staff recommendation be adopted.
