7. PAY 'N' DISPLAY - RATIONALISATION OF ISOLATED PARKING METERS

PURPOSE OF REPORT

1. The purpose of this report is to inform the Board of proposed changes in the control of kerbside parking areas within the central city. The changes have been brought about by the Council's decision to remove the existing parking meters and replace them with "Pay and Display" meters. A report seeking approval for the changes and including any comments from the Board, will be presented at the 6 July 2006 Council meeting. There are a number of changes from page 21-25 of the agenda that do fall under the Board's delegated authority.

EXECUTIVE SUMMARY

- 2. "Pay and Display" parking meters are to be installed within the City, this is scheduled to be completed by 16 July 2006. These meters will replace all the existing meters. Formal resolutions are required to legally define and describe all parking areas changing from the existing meters to Pay and Display and to cover the rationalisation of isolated parking meters.
- 3. A single new meter will service multiple parking spaces. In the interests of efficient placement of the new meters, ideally a single meter will service a minimum of four and a maximum of eight individual parking spaces. There are currently a small number of locations within the City where there are isolated pockets of less than four metered spaces. Rationalisation of these areas is required through changes in how these spaces are managed. In all cases the priority has been to preserve the same number of spaces. Generally the changes involve the conversion of the spaces to a short term parking restriction or the re-arrangement of the existing parking controls to increase the number of parking meter spaces in a cluster. In a small number of locations a new meter will service only three spaces.
- 4. There has been thorough consultation regarding the proposed changes with the businesses directly affected by a specific change. Overall the proposed changes have been well received and welcomed. In some instances there has been concern expressed over a specific change, however, the issues have been worked through and an amicable agreement has been reached.
- 5. Overall the proposed rationalisation results in a net loss of 17 metered spaces (29 removed, 12 installed). The majority of these spaces are intended to be converted to "P5 At Any Time" restrictions consistent with the type of short-term parking restriction most common to the central city.

FINANCIAL AND LEGAL CONSIDERATIONS

Cost

6. The implementation of "Pay and Display" meters and the associated changes to signage and road markings are within existing budgets.

Legal

7. The Land Transport rules provide for the installation of parking restrictions including meters.

8. CENTRAL CITY LOADING ZONE REVIEW

PURPOSE OF REPORT

The purpose of this report is to inform the Board of a comprehensive review of Loading Zones within the central city. The review results in a number of proposed changes to kerb side parking controls. A report seeking approval for the changes and including any comments from the Board, will be presented at the 6 July 2006 Council meeting. As noted in the previous report there are a number of changes that fall within the Board's delegated authority. These are noted on pages 35-38.

EXECUTIVE SUMMARY

- 2. Over the years there have been a number changes to the location and status of loading zones within the central city. These changes have generally occurred on a case by case basis as a result of individual requests from the public. However, there is a need to consider the provision of loading zones comprehensively across the central city to ensure consistency and the most efficient use and management of kerbside parking space. A review of the loading zones within the central city has been conducted. The data obtained from the review will enable informed decisions to be made concerning new requests, alterations and removal of loading zones.
- Another matter driving the review is the confusion experienced by the general public concerning the legal use of the existing zones. This confusion is considered to stem from the fact that there are a number of different types of zones within the city. Loading zones are required to be used for the loading and unloading of goods. However, in practise they are used by the general public to meet a demand for short term parking irrespective of any need to load or unload goods. The confusion concerning the appropriate use of the zones and the demand for short term parking results in a proliferation of illegally parked vehicles within the existing zones. This in turn contributes to the inability of legitimate users to gain access to the zones to load and unload goods, which in itself, gives rise to inappropriate parking. Enforcement is problematic and the extent of the problem is difficult to resolve through this mechanism alone.
- 4. The cycle of illegal and inappropriate parking can be broken by managing the available space in a manner that more accurately reflects the user demand and reduces and/or eliminates confusion. This can be achieved by converting all existing P5 Loading Zones to "P5 At Any Time". This change will meet the demand for both loading and short term parking without prejudice. The duration of stay becomes the sole consideration which will simplify enforcement and remove confusion.
- 5. However, there is also a need to improve the level of service for goods vehicle operators requiring available space to load and unload goods on a regular basis. Currently there are only a small number of dedicated "Goods Vehicle" loading zones relative to "P5 Loading Zones". It is therefore proposed to increase the number of "Goods Vehicle Only" zones and place them in strategic locations to optimise their use. It is also proposed to increase the length of these zones, where appropriate, to better accommodate the types of vehicles that will frequent the zones.
- 6. The review has examined the location, size, signage and general appropriateness of all loading zones within the central city. This has resulted in proposals to relocate, remove and install new zones in a number of locations.
- 7. There has been extensive consultation with stakeholders throughout the entire review process; from the gathering of zone users' requirements through to specific consultation with affected business owners and proprietors. Overall the proposed changes have been well received and welcomed. In some instances there has been concern expressed over a specific change, however, the issues have been worked through and in most instances an amicable agreement has been reached.
- 8. The proposed changes will not diminish the number of metered parking spaces or the total number of parking spaces available for the general public. In fact, due to the rationalisation of the zones there will be a modest increase in the number of spaces controlled by meters (six additional spaces).

9. A diagram of the proposed location of existing and proposed *Loading Zones* is provided in **Attachments 1 and 2**.

PURPOSE OF REPORT

 The purpose of this report is to inform the Board of new bus stop and shelter locations required in the Board's area following consultation with residents. The board is asked to approve the creation of two new bus stops and four new shelters.

BACKGROUND

- 2. The Transport and City Streets Unit have received a request from local residents for a pair of bus stops with accompanying bus shelters to be located on Linwood Avenue between St Johns Street and Dyers Road. Following consultation new locations for the stops have been identified and are recommended below. The need for additional bus stops in this area arises from recent residential development along this section of Linwood Ave.
- 3. The Christchurch City Council is required to provide bus stops to enable the various services to operate in an effective and efficient manner.
- 4. The Transport and City Streets Unit have also received requests for the erection of new bus shelters at existing bus stops. Following consultation locations for two new shelters have been identified and are recommended below.
- 5. In 1998 a joint initiative between Environment Canterbury and the Christchurch City Council saw the development of the Public Passenger Transport Strategy (1998). The strategy set out a programme of improvements designed to dramatically improve public transport services in Christchurch. Among other things these improvements include a target of 500 bus shelters to be installed by June 2006.

BUS STOPS

6. The stops have been located to maximise access to the surrounding catchment area while allowing the bus to travel as freely as possible and to stop a minimum number of times. The distance between the stops will be convenient for bus patrons. The two new stops will service the number 21 bus route.

BUS SHELTERS

7. The shelters have been located to maximise the improvement of public transport services by providing more convenient and comfortable facilities.

CONSULTATION

- 8. In locating new stops, the Council investigates a number of locations to assess suitability. It consults as a courtesy the property owner adjacent to a suitable location. It is preferred to locate stops where agreement has been gained from the property owner.
- Agreement has been gained from the owner of 5 Kidbrooke Street and the Greenspace Unit for the road reserve opposite 5 Kidbrooke Street, to establish permanent bus stops and bus shelters outside these properties.
- 10. Consultation has been undertaken with the owners and occupiers of the following properties for the erection of a bus shelter. Agreement has been gained from the owners of 572 Gloucester Street and the Greenspace Unit for the road reserve opposite 477 Linwood Avenue.

FINANCIAL AND LEGAL CONSIDERATIONS

Costs

11. Two "Metro" signs at \$1,000 each installed met within existing budgets.

12. The sites for the shelters will be offered to Adshel and if accepted, would be at no cost to the Council. If Adshel does not accept the site then the cost to the Council would be \$10,000 which can be met within existing budgets.

Legal

- 13. Land Transport Rules Traffic Control Devices 2004 provides for the erection of bus stop signs.
- 14. Under Section 339 of the Local Government Act (1974) the Council may erect on the footpath of any road a shelter for use by intending public-transport passengers or taxi passengers provided that no such shelter may be erected so as to unreasonably prevent access to any land having a frontage to the road. The Council is required to give notice in writing to the occupier and owner of property likely to be injuriously affected by the erection of the shelter, and shall not proceed with the erection of the shelter until after the expiration of the time for objecting against the proposal or, in the event of an objection, until after the objection has been determined.

STAFF RECOMMENDATIONS

- It is recommended that the Board approve the installation of two bus stops in the following locations:
 - (a) On the north side of Linwood Avenue commencing at a point 22 metres from the intersection with Kidbrooke Street and extending in a westerly direction for 12 metres (5 Kidbrooke Street).
 - (b) On the south side of Linwood Avenue commencing at a point 183 metres from the intersection with St Johns Street and extending in an easterly direction for 12 metres (opposite 5 Kidbrooke Street).
- 2. It is recommended that the Board approve the installation of bus shelters in the following locations:
 - (a) On the north side of Linwood Avenue adjacent to 5 Kidbrooke Street.
 - (b) On the south side of Linwood Avenue adjacent to road reserve (opposite 5 Kidbrooke Street).
 - (c) On the south side of Linwood Avenue adjacent to road reserve (opposite 477 Linwood Avenue).
 - (d) On the south side of Gloucester Street adjacent to 572 Gloucester Street.

PURPOSE OF REPORT

 The purpose of this report is to seek the Board's recommendation to the Council to consent to stop the portion of Richmond Hill Road adjoining the property at 62 Richmond Hill Road shown as Section 1 on Survey Office Plan 370606 (Attachment 1).

EXECUTIVE SUMMARY

- 2. Following a meeting of the Hagley/Ferrymead Community Board on 9 November 2005, the Council, on 8 December 2005, considered a staff report discussing an exchange of land with the owner of 62 Richmond Hill Road. The areas of land for exchange are shown on the attached Scheme Plan SM1436-02 (Attachment 2).
- 3. The exchange provides for the Council to obtain ownership of the land (Section 2) that is currently occupied and used as part of the adjoining Council accessway, and the owner of 62 Richmond Hill Road to obtain ownership of the area of road occupied by a single garage and appurtenances (Section 1) servicing the property.
- 4. In order to facilitate the proposed land exchange, the Council is required to go through a road stopping process in respect of Section 1.
- 5. The Council, and the owners of 62 Richmond Hill Road have entered into an Agreement to Exchange Land and the Council is now in a position to declare the road stopped to enable the exchange to be completed by way of contemporaneous transfer.

FINANCIAL AND LEGAL CONSIDERATIONS

Financial

- 6. There will not be any exchange of monies on the basis that there is significant benefit to Council to acquire ownership of Section 2.
- 7. Costs associated with the road stopping process (in the order of approximately \$5,000) will be funded from the subdivisions account controlled by the Transport and City Streets Unit.

Legal

- 8. The Board does not have authority to consent to stopping a road, such decisions can only be made by the full Council. The Board does, however, have recommendatory powers.
- 9. In December 2005 the Council agreed to stop the road pursuant to the Public Works Act 1981. The relevant sections of the Act are outlined below.
- 10. Section 116 Public Works Act 1981 Stopping Roads

This Section says that, subject to the consent of the territorial authority and the owner(s) of the land adjoining the road in writing to the stopping, then the road can be declared formally stopped by notice in the Gazette.

11. Section 120 Public Works Act 1981 - Registration

This Section provides for the road to be amalgamated with the adjoining land and vesting of the same in the registered proprietor for the time being of the land in that certificate of title.

STAFF RECOMMENDATIONS

That the Board recommends that the Council pass the following resolution:

- That the area of legal road adjoining 62 Richmond Hill Road and described as Section 1 on Survey Office Plan 370606 be declared stopped pursuant to Section 116 of the Public Works Act 1981.
- 2. That pursuant to Section 120(3) of the Public Works Act 1981, Section 1 on Survey Office Plan 370606 be amalgamated with Certificate of Title CB510/20.

PURPOSE OF REPORT

1. The purpose of this report is to formally update the Board on the outcomes arising from a public meeting and to recommend the best way forward.

BACKGROUND

- A Local Area Traffic Management Scheme (LATMS) was prepared for the Avonside area in 1995. This looked at all the issues in the area bounded by the Avon River, Woodham Road and Kerrs Road.
- 3. Some of the proposals in the Avonside LATMS are in place with work being carried out in 2000 at the intersection of Avonside Drive and Torlesse Street.
- 4. To have more traffic calming works carried out in Torlesse Street, it would need to achieve funding from the Neighbourhood Improvement Works budget.
- 5. There is a ranking system used to allocate Neighbourhood Improvement Works funding which takes into account the speeds and volumes of vehicles, the percentage of through traffic, numbers of trucks and roadside usage like shops, parks, schools etc.
- 6. Neighbourhood Improvement Works are not expected to eliminate "hoon" behaviour. In some cases, Neighbourhood Improvement Works can encourage this behaviour as the traffic calming becomes a challenge or the cobblestoned areas are used for "burn outs".
- 7. The residents of Torlesse Street presented a petition to the Board on 7 July 2004 expressing concern at the large number of vehicles that use this street, engage in burnouts and drive in an unsafe and dangerous manner throughout their neighbourhood.
- 8. Torlesse Street has been evaluated under the Neighbourhood Works rating system and currently sits right on the threshold for budget allocation. This means that it only just gets onto the list for funding. However, new projects that are ranked higher will of course get funding ahead of Torlesse Street unless the conditions in Torlesse Street change.
- 9. The Board met on site on 7 September 2005 with staff and residents to gather first hand the residents concerns.
- 10. The Board also allocated \$10,000 of its 2005/06 project funds for some safety improvement work in the street.
- 11. A report was prepared which suggested two possible traffic calming measures for Torlesse Street:
 - (a) The installation of four road humps at an estimated cost of \$14,000.
 - (b) Concept combinations:
 - Stop control on Torlesse Street at Holland Street.
 - Road narrowing at the redundant cul-de-sac, estimated cost of \$70,000.
 - Intersection platform at Braemare Place, estimated cost of \$40,000.

These were presented to the Board at a seminar on 7 December 2005. The Board decided to meet with residents again so that these options could be discussed.

- 12. A public meeting was held in the Dallington Bowling Club rooms on 8 March 2006. Residents confirmed their view from the on site meeting that they did not want speed humps. The lack of funding for the other option/s was discussed and it was agreed that:
 - (a) Staff would look at low cost "stick on" options
 - (b) Board members agreed to liaise with the Police to request that some additional traffic enforcement be carried out in the area.
 - (c) Staff agreed to arrange for the speed trailer to be used in Torlesse Street.
- 13. The results of the speed trailer survey were:
 - East bound traffic was recorded on 21 and 29 March 2006. Average speed 41 and 42 km/h and 85% of the vehicles were travelling at 51 and 51 km/h or less.
 - West bound traffic recorded on 23 and 31 March 2006. Average speed was 38 and 36 km/h and 85% of the vehicles were travelling at 46 and 44 km/h or less.
- 14. The average daily volume of heavy vehicles was seven (surveyed previously in October 2005).
- 15. These survey results were similar to an earlier one taken in September 2004 which were:
 - Combined east and west bound traffic. Average speed was 45 km/h and 85% of the vehicles were travelling at 54 km/h or less.
 - The average daily volume of vehicles was 634.
- 16. No injury crashes have been recorded along Torlesse Street on the Land Transport database since May 2004. In the five years prior to 2004 there were only two reported crashes with alcohol a factor in both crashes.
- 17. The estimated cost for a low cost "stick on" "angled slow point" at the redundant cul-de-sac (Attachment 1) is \$22,245. It would cost an additional \$8,765 to include landscaping of with this treatment.

EXECUTIVE SUMMARY

- 18. (a) Residents are genuinely concerned about traffic issues in Torlesse Street but are not prepared to accept a number of speed humps which would help solve the issues.
 - (b) The Board has made every possible effort to assist the residents by perusing all available options and facilitating meeting seven to the extend of being prepared to fund \$10,000 towards physical works.
 - (c) The evaluation of Torlesse Street, however, puts it on the bottom of the city wide ranking list. It is not appropriate to provide additional funding when there are so many other claims for this sort of work.

STAFF RECOMMENDATION

That the residents at Torlesse Street be informed that:

- 1. It is not possible to carry out any suitable traffic calming work with the \$10,000 allocated by the Community Board.
- 2. The current traffic behaviour does not justify additional Council funding at this time.
- 3. Torlesse Street will be regularly monitored together with other city wide requests for funding from the Neighbourhood Improvement Works budget.

EXECUTIVE SUMMARY

- 2. Eamonn Marra is a 16 year old, year 12 student, seeking funds to assist in attending a one year AFS (American Field Scholar) Exchange Programme departing in August 2006 and returning in July 2007.
- 3. This is the first time the applicant has approached the Board for funding support.

FINANCIAL AND LEGAL CONSIDERATIONS

4. There are no legal issues to be considered. The following table provides a breakdown of the funding requested:

- 5. AFS is a registered charity. The national office of AFS in Wellington will ensure that all monies received are dedicated to Eamonn Marra's Exchange and can provide documentation to enable the sponsor/funder to verify the use of these monies.
- 6. This application is eligible under the Council's Youth development scheme guidelines. It aligns with providing support or assistance to an individual aged 12-25 years under the educational and personal capacity building categories. The Board agreed at the Hagley/Ferrymead Community board meeting on 12 October 2005, to consider applications using these guidelines, on a case by case basis from discretionary funding.
- 7. Currently there is a shortfall of \$4650.

STAFF RECOMMENDATION

It is recommended that the Board allocate \$500 Youth Development Funding to Eamonn Marra toward his AFS Exchange Programme opportunity.

CHAIRPERSON'S RECOMMENDATION

That the staff recommendation be adopted.

BACKGROUND

- 8. Eamonn Marra lives in the Hagley/Ferrymead area, mother in Woolston and father in Linwood, and is a year 12 student attending Shirley Boys High School.
- 9. Eamonn has been selected to go on a one year AFS (American Field Scholar) Exchange Programme in July/August 2006. The school is supportive of his taking time away from studies for this opportunity, and commented that Eamonn is a very sociable independent young man who will benefit greatly from this experience.
- AFS has a history of volunteerism, exchange programmes proven to contribute to the development of cultural, educational and employment skills and values of programme participants.
- 11. A letter of support from AFS states Eamonn has demonstrated that he possesses the qualities which are required of AFS participants. He will continue to be supported by AFS, through orientation sessions and chapter activities.
- 12. The total required funding of the trip is \$10,650 (not including spending money) and covers travel, educational, camping and medical fees. Eamonn has currently raised approx \$6,000 inclusive of \$1,500 from the AFS scholarship fund.
- 13. Eamonn has been working consistently to raise funds toward the cost of the exchange inclusive of part-time work at Mary Gray Confections, packing sweets, Piko Wholefoods Co-op recycling cardboard boxes, regular Sunday sausage sizzle at the Vege Pot, garage sale, chocolate and Christmas tree sales, and holiday work as a junior office temp.
- 14. Eamonn has an interest in cultures and cultural interaction and hopes to attend Victoria University to study Anthropology on his return.
- 15. Eamonn has agreed to present to the Board on his return.

2. The applications is for Ruka Walker, a 13 year old seeking funds to assist in travel to Oahu, Hawaii for a camp and cultural exchange with "Ke Ola Hou", a native Hawaiian Youth organisation.

This event will occur from 23 June to 7 July 2006.

3. This is the first time the applicant has approached the Community Board for funding support.

FINANCIAL AND LEGAL CONSIDERATIONS

BACKGROUND ON RUKA WALKER

- 5. Ruka is 13 years old and lives in Shakespeare Road, Waltham and attends Waltham school. He has been given the opportunity to attend due to an unforeseen, last minute cancellation. Every young person going on the trip is expected to take a leadership role and have been identified as a young person with leadership potential. Ruka has also been identified as a leader through Te Ora Hou and at school and has the school's full support to attend this cultural exchange.
- 6. Ruka will be going as part of a Te Ora Hou national group, including Te Ora Hou youth groups in Whangarei and Hastings. As part of the trip they are required to learn haka, waiata and be prepared to share what life is like in New Zealand. They are also required to interact proactively with others their own age, learn new skills and experiences and appreciate different cultures and customs. The organisation, Te Ora Hou, focuses on at risk youth at large but who are predominantly Maori and Pacific. Their aim is to build positive relationships with young people and for young people to develop the skills and self esteem required to lead constructive, successful lives.
- 7. This is a reciprocal exchange. Last year Ke Ola Hou travelled to New Zealand to take part in Tautoko, the Te Ora Hou National Youth Hui based at Nga Hau E Wha.
- 8. The total cost of the trip is \$2,772. Ruka and a committed team of fundraisers have been arranging various fundraising activities, getting after school jobs, sponsorship and generally working really hard to raise the required money. For a 13 year, this has been a demanding and a worthwhile challenge to gain a life changing experience that he will never forget.

 - (a) Youth Development Scheme Applications (\$800)

Reports will be presented to the Board meeting on 28 June seeking funding for \$800.

(b) Phillipstown Community Centre Charitable Trust (\$3,000)

An application for funding of \$3,000 has been received from the Phillipstown Community Centre Charitable Trust for their programme of a Breakfast Club. This club provides breakfast for children who arrive at school without having breakfast. The funding will go towards wages - two staff members need to be present at all times for health and safety issues. There is a coin donation system. Investigation is currently underway for CYF approval to access MSD funding. Up to 25 children attend daily.

(c) Waltham Integrated Artwork (\$5,000)

The total cost of the artwork including a plaque, seat and preparation for installation is \$25,640. To date \$15,000 has been provided, Greenspace can provide up to \$2,000. Along with funding sought from Solid Energy the Board may wish to provide a further \$5,000 to the cost of the Project.

STAFF RECOMMENDATIONS

- 1. That the \$10,000 remaining in the Torlesse Street project be returned to the Board and added to its discretionary fund for reallocation to other projects.

PURPOSE OF REPORT

1. The purpose of this report is to seek the Board's support that the Council introduce a private plan change to the City Plan. The plan change has been prepared by Robson Garland Limited, following discussions with Council officers. This report is intended to bring the Council's attention to all the issues that surround the proposal.

EXECUTIVE SUMMARY

2. Planning consultants Robson Garland Limited have lodged a plan change request to rezone the properties at 23 and 25 Moorhouse Avenue from Living 4B to Business 3. The application notes that these two sites are the only properties zoned Living 4B that front Moorhouse Avenue and the rezoning will create a logical and consistent zoning pattern in relation to surrounding business uses. All neighbouring properties were notified of the proposed rezoning. This process did not reveal any major concerns by neighbours in relation to the plan change.

The request conforms with the Council's policy on applications for plan changes in that:

- The costs incurred by the Council in processing the application will be recovered from the applicant.
- The application does not involve an important strategic or policy issue.
- The proposed rezoning does not affect a significant area of land that would pre-empt options for urban growth.
- The sites are not within a Priority 1 Area Plan.

The consultation process did not reveal any major concerns by neighbours in relation to the plan change.

The Plan Change and Section 32 analysis are set out in Attachment 1 to this report.

FINANCIAL AND LEGAL CONSIDERATIONS

3. This being a private plan change, the applicant is funding the preparation of the Plan Change. Consequently the financial costs to the Council will be minor, consisting only of limited staff time to review Robson Garland Ltd's work and process the notification and hearing of the plan change. These costs will be recovered.

STAFF RECOMMENDATION

It is recommended that the Board agree that the Council publicly notify Plan Change 2 to the City Plan.
