#### **PURPOSE OF REPORT**

- 1. The purpose of this report is to provide the Riccarton/Wigram Community Board with a brief progress update on activities/projects supported by the Board's 2005/06 Project and Discretionary funding.
- 2. A more comprehensive accountability report will be prepared by staff after the conclusion of the 2005/06 financial year.

#### **DISCRETIONARY FUNDING**

3. The funding available to the Board for the 2005/06 financial year was \$390,000. At its funding allocation meeting on 22 March 2005, the Board retained the following amounts for allocation during the year:

- 4. At its meeting on 14 June 2005, the Board resolved to allocate \$6,000 from its 2005/06 Project Funds to its 2005/06 Discretionary Fund (thus bringing its total to \$59,500) and \$12,000 from its 2005/06 Project Funds to its Community Initiatives Fund (thus bringing its total to \$47,000).
