PURPOSE OF REPORT

1. The purpose of this report is to seek the Board's approval of an application for funding from its 2006/07 Youth Development Scheme.

EXECUTIVE SUMMARY

2. Funding is being sought by Mitchell Kerr, a 14 year old St Bede's student, seeking financial assistance to attend the St Bede's Australian Development Tour and compete in the Southern Skies Challenge Tournament being held in Brisbane.
