**PURPOSE OF REPORT**

1. The purpose of this report is to seek approval for an application for funding from the Board's 2006/07 Youth Development Scheme.

**EXECUTIVE SUMMARY**

2. The applicant, Annie Stock, is a 12 year old student from Fendalton.
3. Annie is seeking funding to assist with the costs involved in travelling to Australia for the International Irish Dancing competitions being held from 16 June - 24 June 2007. There will be two competitions, the first in Robina, Gold Coast, and the second in Sydney.
4. Annie is the current New Zealand Champion for her age group and has been a New Zealand Champion for the past four years.
5. Annie qualified for and attended the World Irish Dancing Championships in Belfast in 2006. This trip was completely self-funded. She qualified for this year's World Championships but was unable to attend due to the large costs involved.
6. Annie is a member of the O'Neil Irish Dancing School and she regularly performs at various Council events including the opening ceremony of the Ethnic Football Festival and Culture Galore.

**FINANCIAL IMPLICATIONS**

7. The total cost of the trip is \$1,735 which includes airfares, accommodation, and competition entry fees. Annie has been fundraising for this trip by busking around Christchurch.
8. This is the first time that the applicant has applied to the Fendalton/Waimairi Community Board for financial support.

3. Hayley is seeking Community Board support to participate in the Spirit of Adventure Youth Development 10 day voyage.
4. The Spirit of Adventure voyages provide young people with an opportunity to learn and develop from each other qualities of independence, understanding, and community spirit through the medium of the sea.
5. Hayley has been a member of the Waimairi District Ranger Unit for two years and prior to this she was a Guide and Brownie in the District. She is currently a Ranger In Leadership with the Kendal Brownie Unit.
6. Hayley assists with all aspects of the weekly Brownie meeting including planning, record keeping, communicating with parents and overseeing and participating in an exciting and fun-filled programme for the girls aged 7-10 years.
7. She is in Year 12 at Villa Maria College and is working towards her NCEA Level 2. Hayley also works on a Friday night and Saturday at Freshchoice in Merivale Mall, and undertakes babysitting regularly, as a means of providing some additional funding towards her Spirit of New Zealand voyage.
