**PURPOSE OF REPORT**

1. The purpose of this report is to seek the Board's approval of an application for funding for \$500 from its 2006/07 Discretionary Fund. There is a nil balance in the 2006/07 Youth Development Fund.

2. \$1,000 is being sought by Simon Kersten, a 19 year old who lives in Ilam, towards costs associated with participating in the Tower New Zealand Youth Choir in its upcoming trip to choral festivals in Canada, Wales and Spain.
