PURPOSE OF REPORT

1. The purpose of the report is to request funding support from the Spreydon/Heathcote Strengthening Communities Action Plan (SCAP) Committee, for the printing and development of the 5th edition of the Directory of Community Information and associated website development.

EXECUTIVE SUMMARY

- 2. The Directory originated as a Strengthening Communities Action Plan (SCAP) project, with the aim to facilitate information to people, and increase community access to local resources and services.
- 3. The Directory was first printed in 1998, with a total of 7,000 being produced. In 2000 approximately, 22,000 copies of the Directory publication were distributed to each letterbox in the Spreydon/Heathcote ward. Thereafter, the Directory was intended to be published annually, however, due to the cost these were only produced every two years in 2002 and 2004.
- 4. The information that is included in the Directory is also available on the CINCH database, which is accessed through the Library website, however, feedback from residents indicated the need for a local hard copy version to be continued. The Strengthening Community Action Plan Committee (SCAP) supported the production of the 2002 and 2004 directories.
- 5. The Directory includes information on services such as health, welfare, education, local/central government agencies actively involved with community development, other helping agencies and a vast number of mainly voluntary organisations, community groups, and sports clubs. It also includes community facilities in the Spreydon/Heathcote area.
- 6. Current feedback on the value of the Directory, indicates the printed version as a valuable resource for the Spreydon/Heathcote area, with community workers, older adult networks and community cottages in particular, supporting production of an updated edition. Discussions have also indicated that a reduced print run with development into a web based application is the way forward for this community resource.

7. It is proposed that limited print runs to a maximum of 2,000 Directories will service the required community need for booklets, with the scope to reprint if demand exceeds supply later in the year.

FINANCIAL IMPLICATIONS

- 8. Cost of digitally printing each Directory with a preferred printer, colour front page and body of directory black and white is \$1.65 plus GST per copy. The advantage of using digital reproduction is that there is no set-up fee, and updated versions can be printed on an as needed basis.
- 9. As a new development, the 5th edition would be produced as a web-based application to complement a smaller run of hard copy resources. Initially this would be available with the Spreydon/Heathcote Community Board web site. Development of the Directory so that it is more interactive as a database as updates are automatic on the web version and specific searches viable, are currently being investigated as part of this new initiative.
- 10. The total cost of producing this directory is budgeted as follows:

Printed Document, 2000 copies	\$3,300
Web based application development	\$2,500
Total cost estimate based on the above	\$5,800
