PURPOSE OF REPORT

1. To assess a funding application from the Akaroa Community Arts Council for discretionary funding from the Akaroa/Wairewa Community Board to apply to projects including advertising, signage, marketing material and marquee for an outdoor event.

EXECUTIVE SUMMARY

- 2. The Akaroa Community Arts Council has become proactive in encouraging and enabling residents to try new creative activities, learning new skills, recognising and expanding their capabilities. The group has identified demand for workshops and a monthly 'Art Spot' with local works from across a variety of mediums being exhibited during the last week of every month, in different venues. The final 'art spot' for 2007 is to be held at an outdoor venue with a marquee as back-up should December weather be inclement.
- 3. Creative New Zealand funding was secured for a successful paper making workshop held at the end of April. The group is unable to obtain Creative New Zealand funding for materials, capital expenditure or general administration.
- 4. The age range of participants/exhibitors at monthly 'art spots' is 4-84yrs. There was an increase of 50% in visitor numbers and 30% in exhibitors from the first to the second display. The group believe that improved directional signage and banners denoting venue/activity; and increased advertising via print media and posters will increase community participation further.
- 5. The group has previously received \$3,220.00 from the Board's discretionary fund in the 2006/2007 financial year for art supplies, display costs and exhibition display boards and venue hire.
