PURPOSE OF REPORT

1. This report seeks approval of the proposed allocation of the Boards Schedule F funding for 2007/08 – 2009/10.

EXECUTIVE SUMMARY

Schedule F Funding

- 2. Schedule F of Appendix 6 of the Memorandum of Understanding between Banks Peninsula District Council and Christchurch City Council listed projects totalling \$2,985,500 for the Akaroa Wairewa Community Board area. The LTCCP 2006-16 includes a budget of approximately \$315,000 per year to the Transport and Greenspace Capital Programme for capital projects for reserves within the Board area. Board members will recall that staff presented the proposed three year schedule for these funds to Akaroa Wairewa Community Board at a seminar on Wednesday 25 July 2007.
- 3. Attached to this report is the proposed Reserve Development Programme for the Akaroa Wairewa area utilising the Schedule F funding for 2007/08 2009/10 for discussion and approval by Board members (**refer Attachment 1**).
- 4. Board members will recall staff advising, that while many of the reserves have management plans approved and in place, they lack any form of development plan. The development plan is a fundamental component and will essentially be one of the main drivers for any future capital programme for a particular reserve. It will also determine and clarify the order of priority for capital projects on the reserve.

FINANCIAL IMPLICATIONS

5. Schedule F funding is pre-allocated in the LTCCP 2006-16 for reserves projects in the Akaroa Wairewa Community Board area as described in 2 above. The attached proposal lists projects for the next three years which, when approved, will be re-allocated within the Transport and Greenspace Capital Programme to the individual projects listed in Attachment 1.
