PURPOSE OF REPORT

1. The purpose of this report is to seek approval for an application for funding from the Board's 2007/08 Youth Development Scheme.

EXECUTIVE SUMMARY

2. The Burnside Under 15 Premier Football team have seven players in the Fendalton/Waimairi area that are applying for funding assistance to compete in the Champions Youth Cup. This tournament is being held on the Gold Coast, Australia from 29 September to 6 October 2007.
3. The Champions Youth Cup has been held annually for the past 11 years and is an initiative of the Mudgeeraba Soccer Club. The aim of the tournament is for young players to develop football skills, promote cultural understanding and to forge friendships through sport. The tournament attracts teams from all over New Zealand, Australia and internationally. International teams include Nigeria, Wales, Chinese Taipei, Samoa, Cook Islands and New Caledonia. It is the only youth tournament that club teams, as opposed to representative teams, are able to enter, and is seen as a great opportunity for top club players to experience high level competition.
4. The team is made up of the top players from the Under 14 and Under 15 teams that were selected after a series of pre season trials. To date the team has not lost a game this season, conceding only one draw, placing them at the top of the local competition table. The travelling squad will consist of 15 players and five support staff.
5. The team is actively fundraising with garage sales, sausage sizzles, firewood raffles, commission sales and have submitted funding applications to various charitable trusts.

PURPOSE OF REPORT

1. The purpose of this report is to seek approval for an application for funding from the Board's 2007/08 Youth Development Scheme.

EXECUTIVE SUMMARY

2. The applicant, Emily Nicholas, is a 20 year old Canterbury University student living in the Burnside area.
3. Emily is a member of the Canterbury Aerobics Team who have been selected to compete in Federation of International Sports, Aerobics and Fitness (FISAF) World Championships being held in Belgrade, in October this year. To meet the qualifying standards the team was assessed by a top international judge whilst competing at the recent New Zealand Championships. The team convincingly won this event and clearly demonstrated they possessed the expertise to compete at an international level. The team travelling to Belgrade will consist of seven athletes plus one coach/manager.
4. Emily has a background in gymnastics, diving and performing arts. She currently teaches gymnastics part time and is choreographing the Breens Intermediate school production.
5. The team has been training for the World Championships since October 2006. They train together six days a week and in addition members are required to train individually in order to perfect the demanding routine. As a sport aerobics is very demanding, requiring a top fitness, flexibility, power, strength and co-ordination. Athletes are required to entertain and perform to an audience whilst executing their skills with absolute accuracy and perfection.
6. The team is actively fundraising and to date has held a successful trivia night at St Christopher's Church Hall, run a food stall at the Canterbury Schools Aerobics Championships and organised a movie night. In addition to these activities they plan to run a series of aerobics workshops at the College of Education, an under 18 formal ball, and over 18 formal, targeting parents and supporters, and culminating their fundraising with the "Absolute Aerobics Academy Concert". They have also secured \$5,000 in sponsorship.
