1. MINISTRY OF SOCIAL DEVELOPMENT – OUT OF SCHOOL SERVICES

2. POLICING DIRECTIONS IN NEW ZEALAND FOR THE 21ST CENTURY

At the 19 June 2007 Board meeting, Inspector Dave Lawry, Area Commander Southern, New Zealand Police, had given a presentation on the proposed new police legislation. At that meeting the Board offered to assist with consultation on the police legislation with the Residents' Associations in the Spreydon/Heathcote Ward.

Towards this end, Residents' Associations in Spreydon/Heathcote were invited to attend this Finance and Policy Committee meeting and discuss with the Committee and New Zealand Police representative how the Police and Residents' Associations could assist each other to achieve mutually beneficial goals.

Topics covered in the discussions included graffiti, youth education, youth aid, youth crime, neighbourhood support groups, community constables and video surveillance technology.
