- Approach Canterbury Waste Services Ltd concerning proposed consent changes.
- That staff of the constituent Councils carry out a review of the former Canterbury Waste Subcommittee's policy on the appointment and remuneration of directors, Transwaste Canterbury Ltd and report that review back to the Canterbury Regional Landfill Joint Committee.
