PURPOSE OF REPORT

1. The purpose of this report is to seek Board approval for an application for funding from the 2007/08 Spreydon/Heathcote Youth Achievement Scheme.

EXECUTIVE SUMMARY

- 2. Funding is being sought by the applicant, a 15 year old girl who lives in the Huntsbury area, towards costs associated with representing the New Zealand Under 17 Road Cycling Team in the Tour of Canberra.
- 3. This is the first time the applicant has approached the Board for funding support.

BACKGROUND ON HARRIET SMITHIES

- 4. Harriet Smithies is a 15 year old student from Cashmere High School who has been selected by Bike NZ as a member of the New Zealand Under 17 Road Cycling Team to compete in the 2007 Tour of Canberra. The Tour of Canberra is a five day road cycling event and New Zealand is sending two teams of Under 17 riders, one male team and one female team. Harriet is the only female rider selected from the South Island.
- 5. Harriet is a Year 11 student at Cashmere High School. Harriet is an active participant in cocurricular activities and has excelled in her chosen sport of road cycling where she has gained national honours. She is also a member of the school orchestra and is currently playing in the school musical production of 'The Wizard of Oz'.
- 6. Harriet has been road cycling for just over a year and recently competed in the Tour of Canterbury (a five stage race) where she achieved great results. Although a relative newcomer to this sport, Harriet is displaying a natural ability and her talent has come to the attention of the national selectors hence her selection in the national team.
- 7. Harriet's cycling passion started approximately four years ago. Her parents were participating in mountain biking events and, sick of watching from the sidelines, she decided to save up for her own bike so that she, too, could have a go she was soon 'hooked'.
- 8. A year ago Harriet made the change to road cycling and pursued this interest as her winter sport. Enjoyment of this sport and determination to do better has meant training four days a week. Harriet joined the Pegasus Cycle Club and began racing on the weekends, training up to six days a week, with support and guidance from her coach.
- 9. Harriet's coach states that "in the short time he has been coaching her she has made huge progress... and feels that they are only just beginning to scratch the surface of Harriet's natural ability". Harriet's coach feels that she has a big future in cycling.
- 10. Harriet has only recently been notified of her selection in the New Zealand Team to participate in the Tour of Canberra. A new bike purchase and the short notification of selection mean that this family has to source the cost of this trip in a short timeframe. To date, Harriet has raised \$950 towards the cost of this trip and has one funding application currently under consideration with Pegasus Cycling.

PURPOSE OF REPORT

1. The purpose of this report is to seek Board approval for an application for funding from the 2007/08 Spreydon/Heathcote Youth Achievement Scheme.

EXECUTIVE SUMMARY

- 2. Funding is being sought by the applicant, a 16 year old girl who lives in the Cashmere area, towards costs associated with representing the New Zealand Junior Rowing Team at the World Junior Rowing Championships in China.
- 3. This is the first time the applicant has approached the Board for funding support.

BACKGROUND ON LUCY SPOORS

- 4. Lucy Spoors is a 16 year old student from Christchurch Girls' High School who has been selected to represent New Zealand at the World Junior Rowing Championships in Beijing, China in August 2007. Lucy has been selected to represent New Zealand in the Women's Quadruple Sculls at the World Junior Rowing Championships.
- 5. Lucy attended Cashmere Primary School and went on to attend Christchurch Girls' High School where she is currently a Year 12 student. Lucy has been involved in netball, basketball and rowing and has represented Canterbury for all three sports. Her selection in the New Zealand Junior Rowing team means that netball and basketball have been put on hold while she dedicates all her time and energy into training for the World Junior Championships.
- 6. Lucy first started rowing at the end of Year 9. Over the past three years Lucy has achieved a number of good results, winning gold, silver and bronze medals at various rowing championships across the country. This year Lucy was a member of the Girls' High Under 18 Squad to win silver at the AON New Zealand Secondary School Championships at Lake Karapiro.
- 7. Lucy's rowing coach comments "her accomplishments are many, she is an elite high school basketballer and an elite junior rower, not only is she a strong athlete, she is a terrific team player and is very supportive of those around her (both family and friends)".
- 8. In the lead up to the World Junior Rowing Championships Lucy has relocated to Hamilton where she will live for up to three months. During this time Lucy will be private boarding with a family, an arrangement that has been organised by Rowing New Zealand. Living in Hamilton prior to departing for the Championships will allow Lucy to train with her crew mates, ensuring they have the best possible build up prior to departing for Beijing.
- 9. To date, Lucy has raised \$1,000 towards the cost of her trip. Lucy currently has three funding applications lodged with other organisations such as the Lions Foundation and Rotary. A fundraising dinner was held, in conjunction with other members of her team, but the amount raised from that event is yet to be announced.

2. CASHMERE RESIDENTS' ASSOCIATION COMMUNITY VISIONING PROJECT - REQUEST FOR FUNDING
