1. The purpose of this report is to seek approval for an application for funding from the Community Board's 2006/07 Youth Development Scheme.

EXECUTIVE SUMMARY

- 2. The applicant, Benjamin Howes, is a 13 year old St Andrews College student living in Fendalton.
- 3. Benjamin is seeking funding to assist with the costs involved in travelling to Guangzhou, China as a member of the New Zealand U15 Secondary Schools Football Team from the 6th July 15th July 2007. The team will play a warm up game in Auckland and three games in China against top ranked age group teams.
- 4. To be selected for this tour Benjamin attended national trials held in Palmerston North during April this year. There were a total 76 trialists with 6 from the South Island. Benjamin has also been selected for the Mainland Football High Performance Squad.
- 5. Benjamin is a talented all round sports person and is a member of the school first XI cricket team, an accomplished golfer and last year was selected for the Canterbury Metro Under 14 Rugby squad.

FINANCIAL IMPLICATIONS

- 6. The total cost of the trip is \$4,500 which includes international airfares, accommodation, and travel within China. Benjamin's parents have agreed to fund any shortfall.
