##### PURPOSE OF REPORT

1. The purpose of this report is to seek approval for an application for funding from the Board's 2007/08 Youth Development Scheme.

##### EXECUTIVE SUMMARY

2. The applicant, Daniel George Tisch, is a 14 year old student who lives in Riccarton and is seeking Board support to travel to Napier with the Canterbury Under 15 A Boys Hockey team from 9 – 14 July 2007.
3. Daniel has been playing hockey since the age of 7, has been involved in competitive hockey since the age of 11, and has represented Canterbury from 2003. This trip to Napier will offer Daniel the experience required for the development of younger players and to gain selection in future representative teams.

**PURPOSE OF REPORT**

1. The purpose of this report is to seek approval for an application for funding from the Board's 2007/08 Youth Development Scheme.

**EXECUTIVE SUMMARY**

2. The applicant, Sam Rayner Steele, is a 17 year old who lives in Halswell and is seeking Board support to travel to Mexico for the World Track Cycling Championships with the New Zealand Junior Track team. The trip will take place from 5 July to 12 August 2007.
3. Although Sam has only been racing for four years, in that time has won a Youth Olympic medal in Sydney, 5 national titles along with numerous placings. Sam's short term goal is win a world title at the Junior World Track Championships this year and his ultimate goal is to emulate his father, Murray Steele, who represented New Zealand at both Commonwealth and Olympic Games in cycling.
4. Sam's dream of representing New Zealand has become a realisation and this trip to Mexico will be invaluable for him in gaining experience, quality training and racing that will help him become a world class track rider. Financial expenses have increased for Sam and he dedicates all that he earns from his part time job to his sport. Sam is also fundraising for his trip and will continue to do so until he leaves.

**PURPOSE OF REPORT**

1. The purpose of this report is to seek approval from the Board for \$800 funding from the Board's Discretionary Fund to meet signage and promotion costs for the Gilberthorpes School Jubilee to be held in November this year.

**EXECUTIVE SUMMARY**

2. The Gilberthorpes School Jubilee Committee is seeking \$800 from this fund towards the costs of signage and promotion for this event. The committee is anticipating that at least 100 people will attend. The committee hopes that current and past learners and educators of the school will be attracted to the event and that this will contribute to the building of community spirit. Gilberthorpes Primary is a Decile 1 school.
