PURPOSE OF REPORT

1. The purpose of the report is to request funding support from the Spreydon/Heathcote Strengthening Communities Action Plan (SCAP) Committee, for the commissioning of a community visioning project for the Cashmere area.

EXECUTIVE SUMMARY

- 2. The Cashmere Residents Association is interested in developing a community vision for the area that will provide focus to the Association and inform its activities and involvement in local issues.
- 3. Council staff have undertaken an initial exercise with the group to determine their values which has received very positive feedback. This will assist the group to identify and focus on their priorities as well as providing members with greater clarity and confidence in carrying out their activities. This may also work towards ensuring they continue as an active and successful resident association into the future. The group is committed to the community visioning project in the long term.
- 4. This project could be used as a model for work with other communities across the city to guide local communities to determine their focus and involvement in decisions which affect their local community.
- 5. An external provider is required to carry out the scoping, research, data analysis and evaluation. A specialist in this area would require funding from the Committee.

FINANCIAL IMPLICATIONS

- 6. The cost of employing an appropriately qualified person to undertake the visioning exercise with the Association is estimated to be initially \$10,000.
- 7. Staff would determine how much work this funding would cover after discussion with the provider when a suitable person or company was identified and contracted to undertake the project. The contractor and staff would report back regularly to the SCAP Committee on the progress of the project.

PURPOSE OF REPORT

1. The purpose of this report is to submit for consideration, project proposals involving the remaining allocation of SCAP funding for 2006/07.

EXECUTIVE SUMMARY

- 2. The SCAP Committee has available for allocation within this year's budget a balance of \$13,400.
- 3. The following table summarises suggested projects put forward by staff for the Committee to consider, which total \$19,082 (including Cashmere Visioning Project, \$10,000, refer separate report). Further elaboration on each of these items will be provided by staff at the meeting. Clearly there would be a shortfall if the Committee wished to fund all projects put forward for consideration at this meeting.

- 4. Opawa Baptist Church's previous funding request to support the family film evenings was declined due to possible legal complications relating to copyright. The Church has since obtained a formal licence to operate films shown as part of the family nights. While the cost of the copyright licence cannot be considered, as now retrospect, this request would support costs such as the promotion of the project.
- 5. Christchurch Metropolitan Youth Trust has initiated a new mentoring programme, being run out of Opawa School. Two programmes are run under the umbrella of the mentoring programme. The first uses ABL (Adventures Based Learning) techniques to achieve outputs such as working as a team, trust, social skills development and leadership. The second programme works with a core group of young people and focuses on issues such as self esteem, self worth, social skills and making good decisions. This programme was initiated in Term 2, and led by leaders whom are currently not being paid for the work they are undertaking.
- 6. The Graffiti Project is in the beginning stages of development, to focus on the Spreydon Community. The proposed approach will take Graffiti management beyond the clean up focus and involve community in solutions at a local level.
- 7. Spreydon Community Gardens Trust requested funds from SCAP last year to support the "Extension Activities Development Project", which has been working on gardening classes and a home advisory service for new migrants, supporting outreach programme into home composting advisory services, including advisory into Kids Edible Gardens and exploration of a pilot service based at Council Housing Estates. To top-up this initiative at this stage would support the Trust with year end cash-flow pressures.
