## PURPOSE OF REPORT

1. The purpose of this report is to seek approval for an application for funding from the Community Board's 2007/08 Youth Development Scheme.

## EXECUTIVE SUMMARY

2. The applicant, Ricky John Cook, is a 21 year old who lives in Upper Riccarton and is seeking Community Board support to travel to Auckland to compete the National Men's Open Bowls Championship. This event will occur from 15 – 21 November 2007.
3. Ricky has been competing in Bowls for 10 years and this year gained selection in the Academy Canterbury programme for 2007/08 and in the 2007 Canterbury Open Men's squad. These upcoming National Open Championships will expose Ricky to world class competition, which is vital to further develop his skills as a player and competitor.
4. Ricky is very enthusiastic and committed to his chosen sport and financial support will enable him to continue to seek these opportunities to develop his skills. Ricky has raised \$200 towards his costs to date.
