- 6. Christopher has been doing all his own fundraising as he is the only Scout from his Redwood troupe attending the Jamboree. His efforts so far have included painting, odd jobs and gardening. The financial resources of the family are very limited and any assistance from the Board would be much appreciated. This is the first time the applicant has applied to the Board.
